## **Report: Supreme Court Justice Clarence** Thomas Violated Ethics Laws with Multiple Super Yacht Cruises with Republican Donor

Justices are required to report all gifts of \$415 or more that are "anything of value" and not fully reimbursed. There's no record of Thomas reporting the gifts or reimbursing anyone for the trips.

For more than two decades, U.S. Supreme Court Justice Clarence Thomas has accepted luxury trips virtually every year from Dallas businessman and Republican mega donor Harlan Crow without disclosing them, a bombshell new report from ProPublica has revealed.

Citing documents and interviews, the nonprofit and Pulitzer Prize winning legal news organization said Thomas who has a salary of \$285,000, has

vacationed on Crow's superyacht around the globe.

Had Thomas footed the bill himself, one trip on Crow's yacht would have set him back a cool halfmillion dollars.

What's more, the controversial conservative justice often flies on Crow's Bombardier Global 5000 jet. That's a \$70,000 trip.



"He has gone with Crow to the Bohemian Grove, the exclusive California all-male retreat, and to Crow's sprawling ranch in East Texas," the legal news site reported on Thursday, April 6.

"And Thomas typically spends about a week every summer at Crow's private resort in the Adirondacks."

The judges represented Nashville, Shelby County, and Athens.

"The Court finds the implementation of the Act and its reduction provisions at this late date results in an upheaval of the election process, risks voter confusion, and potentially comprises the integrity of Davidson County's August 3, 2023, general election," the judges continued.

Separately, the Federal Aviation Administration has halted a Republican plan to have the GOP takeover Metro Nashville Airport Authority board appoint-

ported chiefly the move in SB1326, and the House was scheduled to hear a similar measure this week.

Reportedly, the FAA Office of Airport Compliance and Management Analysis Director Kevin C. Willis said the agency "has questions regarding the potential impact of transferring the appointment authority of all board members from the mayor of the local community to state-appointed officials."

Currently, Nashville's Democratic mayor appoints board members to the airport, but the GOP wants to take that power from him.

ly called on their colleagues to act on gun control after the latest school shooting in Nashville claimed the lives of three elementary school students and three adults, came amid the continued GOP power grab.

Across the country and in Tennessee, the backlash has been palpable, and even some Republicans have expressed regret for the actions of party members and Sexton, who led the vote to oust Jones and Pearson.

## II CORINTHIANS STUDY II Corinthians 8:1-24

THE SUBJECT OF CHRISTIAN GIVING

By Rev. Johnny Calvin Smith

Having discussed in the first seven chapters on the subject of Christian living, now Paul will deal with the subject of Christian giving in Chapters 8-9. Paul is really dealing with the collection for the poor saints of Jerusalem. Beginning in verses 1-2, Paul relates to us that giving is a grace. He refers to the Macedonian believers as examples in Christian giving.

The Macedonians gave out of their deep poverty.

They did not give out of their abundance, but out of deep poverty. Moreover, the gift in which they gave was given willingly, for they first gave of themselves (vv. 3-5). The gift that the Macedonians took up was a grace; thus, it was taken up as a means of sharing of the things of Christ. As believers today, we should have a deep passion to give of our resources so that the work of Christ would continue. In verses 6-7, Titus was dispatched to administer the Corinthians' portion of the collection, and to give them opportunity to excel in this grace of giving. wanted Corinthians to excel in giving because giving expresses love (St. John 3:11, 16-18). Paul desired in verses 8-9, that the Corinthians' motivation would not stem from external commands. He wanted the Corinthians' giving to come about out of love to the Lord. The

real motivation for giving is found in verse 9.

Christ, leaving the

palace of glory, came down and took a place of poverty. He left the stateliness of heaven to dwell down here among the squalor of the earth! He was rich, but He became poor for you and me! The one who was rich, who had everything, became poor, expressing His generosity as He paid mankind's enormous sin debt by giving His life on a cross of shame (Philippians 2:8). In serving as our substitute for sin, Christ became what we were (poor) so that we would become what He was and is (rich)! A material offering to Him, would that be too much?

In verses 10-12, Paul admonished

Corinthians to finish what they had begun; thus, they needed to carry through with their pledge. The Corinthians were to give in commensurate with their means. A guiding principle for giving among churches is equality (vv. 13-15). Paul was not wanting some church to have relief while the Corinthians would be burdened.

In verse 15, Paul cited how God dispensed food to the Israelites in the wilderness equally according to their needs (Exodus 16:16-18). Paul stated in verses 16-17, that he dispatched Titus to get their offering, for Titus was eagerly determined to lend assistance to this project.

In verses 18-21, a highly respected representative

take the would Corinthians' gift to its destination in Jerusalem. Paul's motivation in organizing this collection was to honor the Lord. Paul wanted to avoid bringing reproach on the Lord's name through charges of mismanagement or avarice (II Corinthians 8:20).

Finally, in verses 22-24, in addition to the previous brother mentioned in verse 18, and Titus, a third brother was appointed to join the collection team. The honorable team would ensure that there would be no profiting from the collection as it goes to Jerusalem. In verse 24, the Corinthians would demonstrate the proof of their love by their giving!

# Dallas City Council approves incentive package to bring Tom Thumb grocery store to RedBird

Southern Dallas food desert welcomes full-service chain

DALLAS - Wednesday, the Dallas City Council awarded Albertsons Companies an economic development incentive package to support the development and operation of a new full-service Tom Thumb grocery store located within The Shops at RedBird.

"This community has expressed its desire to have a quality grocery store that offers fresh foods for so long and attracting a grocery store has been one of our biggest priorities ever since we started to reimagine RedBird," Councilmember Tennell Atkins, Chair of the City's Economic Development Committee. "I'm pleased to say we're making it happen we can't wait to welcome Tom Thumb to the neighborhood."

The 50,000-square-foot grocery store would sit on five acres at the southeast corner of Camp Wisdom and Westmoreland Roads within The Shops at RedBird redevelopment area. The proposed retail store will be a million in conditional grants

# Mavs GM Harrison stays guarded on NBA probe, Irving, Doncic

Mavericks general manager Nico Harrison said he didn't expect the trade for Kyrie Irving to spark a playoff run the way his first blockbuster move did a year earlier.

Missing the postseason completely started the clock early for the Mavs in their attempt to re-sign Irving in free agency and see how the pairing with fellow All-Star Luka Doncic looks long-

The exit interview with Irving was Monday, the day after the season ended under the cloud of an NBA investigation. The league announced the probe after Irving didn't play and Doncic was limited to the first quarter when Dallas still had a chance to make the play-in tournament with two games remaining.

Irving and Doncic both

finale after a loss to Chicago in the game in question eliminated the Mavs a season after they went to the Western Conference finals.

Harrison said Tuesday he didn't know much about the NBA's investigation and wouldn't comment further. The 0-2 finish by Dallas put the club in the best position possible to keep a firstround pick that otherwise will go to the New York Knicks from Dallas' 2019 trade for Kristaps Porzingis.

The second-year GM wasn't much more enlightening on the topics of Irving's future and the mindset of Doncic, who openly expressed his frustration with a losing season and said off-court issues were taking away his joy for the game.

Nets. "I think the things that he said along the way about how he feels here, how he feels appreciated, how he feels accepted and allowed to be himself," Harrison said. "I think those are the things that he's said kind of consistently, and that's what gives me the optimism that he wants to be here."

Doncic said he didn't agree with, but understood, the decision to sit Irving and four other regulars on the night he played before coming out a few seconds into the second quarter of a 115-112 loss to the Bulls, when a

rag-tag bunch of reserves couldn't hold an 11-point lead in the fourth quarter.

The 24-year-old said in his season-ending interview he was happy in Dallas, and Harrison said he didn't go to sleep at night worried about Doncic's future because the four-time All-Star has three years left before a player option kicks in on the \$215 million rookie supermax contract he signed two years

Still, there's the question of keeping Doncic happy in Dallas with plenty of recent scenarios around the league of unhappy superstars forcing their way out.

"I don't know what keeping Luka happy here means," Harrison said. "If you win, then I'm assuming he's going to be happy. If we win and he's not happy, think the goal is to win. I'm assuming that works. It will work for me."

Before the 2022 trade deadline, Harrison sent Porzingis to Washington in a deal that brought Spencer Dinwiddie to Dallas. Dinwiddie was an important piece of the run to the West finals, but he went to the Nets along with defensive ace Dorian Finney-Smith in the deal for Irving.

Harrison said the difference between the outcomes in the two trades was the Mavs were already on a roll when they made the move last year. This year, a team that couldn't find the same defensive formula got even worse on that end without Finney-Smith, and never found traction.

## **Biden Issues Proclamation** for Black Maternal **Health Week**

On Monday, April 10, President Biden issued another proclamation to begin Black Maternal Health Week.

Vice President Kamala Harris convened a meeting with Becerra and other Cabinet leaders amplifying whole-of-government approach to reducing maternal mortality and morbidity.

On Monday, April 10, President Biden issued another proclamation to begin Black Maternal Health Week.

The president called the week a reminder that so many families experience pain, neglect, and loss during what should be a joyous occasion.

Biden called it urgent that all act.

"Black women America are three times more likely to die from pregnancy-related complications than white women," the president remarked.

"This is on top of the fact health disparities, and this that women in America are year, the Biden-Harris dying at a higher rate from Administration has contin- pregnancy-related causes than in any other developed nation."

> He insisted that tackling the crisis begins with understanding how institutional racism drives these high maternal mortality rates.

> Studies show that Black women are often dismissed or ignored in hospitals and other health care settings, even as they suffer from severe injuries and pregnancy complications and ask for help, the president reminded.

He said systemic inequities are also to blame.

"When mothers do not have access to safe and stable housing before and after childbirth, they are at greater risk of falling ill," Biden exclaimed.

The extent and frequency of Crow's apparent gifts to Thomas have no known precedent in the modern history of the U.S. Supreme Court, and ProPublica further notes that the trips appeared nowhere Thomas' financial disclo-

"His failure to report the flights appears to violate a law passed after Watergate that requires justices, judges, members Congress and federal officials to disclose most gifts," the site reported, citing two ethics law experts.

Thomas, the experts said, also should have disclosed his trips on the yacht.

"It's incomprehensible to me that someone would do this," Nancy Gertner, a retired federal judge appointed by President Bill Clinton, told ProPublica.

When she was on the bench, Gertner said, she was so cautious about appearances that she wouldn't mention her title when making dinner reservations: "It was a question of not wanting to use the office for anything other than what it was intended."

Virginia Canter, a former government ethics lawyer who served in administrations of both parties, said Thomas "seems to have completely disregarded his higher ethical obligations."

"When a justice's lifestyle is being subsidized by the rich and famous, it absolutely corrodes public trust," said Canter, now at the watchdog group CREW.

"Quite frankly, it makes my heart sink."

As ProPublica noted, federal judges sit in a unique position of public trust.

barriers traveling to the hospital for prenatal and postpartum checkups, they are less likely to remain healthy. Air pollution, water pollution, and lead pipes can have dangerous consequences for pregnant women and newborns. And when families cannot afford nutritious foods, they face worse health outcomes."

He claimed his administration has penned the blueprint for addressing the maternal health crisis, an agenda that lays out specific actions the federal government would take to improve maternal health and secured funding from Congress to help implement

"Vice President Kamala Harris has been a leader on the issue of maternal mortality for years and led the charge to improve maternal health outcomes, including by issuing a call to action to address disparities in maternal care," Biden stated.

"She continues to elevate the issue nationally, convening State legislators, medical professionals, and others so all mothers can access the care they need before, during, and after childbirth."

The president continued: "Additionally, American Rescue Plan gave States the option to provide a full year of postpartum coverage to Medicaid beneficiaries — up from just 60 days of coverage.

"As a result, Administration has approved requests from 30 States and Washington, D.C. to provide women with Medicaid coverage with a full year of postpartum coverage, and we have made this option permanent for every State that extends Medicaid postpartum cov-

"My Administration has helped facilitate Medicaid expansion in four States since I took office, and I continue to call on the Congress to close the Medicaid coverage gap.

"We are also working to expand and diversify the maternal health workforce, helping health providers hire and train diverse and culturally competent physicians, certified nurse midwives, doulas, and community health workers to support women during pregnancy, delivery, and postpartum care."

The president's budget includes \$471 million to reduce maternal mortality morbidity rates, improving access to care in rural communities, expanding implicit bias training for health care providers, and further supporting the perinatal health workforce.

"This week, as we continue our work to make pregnancy and childbirth safe, dignified, and joyful for all, let us remember that health care should be a right and not a privilege,"

AUSTIN, Texas (AP) — An alternate juror in the than 24 hours after the vertrial of a U.S. Army sergeant convicted of murder said Wednesday that Texas Gov. Greg Abbott's rush for a pardon is an "egregious overreach" to wipe aside the jury's unanimous decision over a 2020 shooting during a Black Lives Matter protest.

In an interview with The Associated Press, Jere Dowell said prosecutors put on a convincing case against Daniel Perry, who was in his car working as a ride-share driver when he not previously supported shot 28-year-old Garrett Foster, who had been legally carrying an AK-47 while that Abbott wading into the marching with demonstrators through downtown Austin.

As an alternate, Dowell did not have a vote in convicting Perry but said she was in the room for deliberations and she agreed with the verdict handed down Friday.

"I just think it's a travesty," Dowell said of Abbott already seeking a pardon.

Her comments are the first time a juror has spoken Republican, announced Saturday he would use the power of his office and seek to wipe away the verdict. Legal experts have called the governor's move highly unusual and prosecutors condemned it as troubling.

Abbott made his inten-

tions known on Twitter less dict and amid outrage from conservative voices on social media and television over the conviction.

"I just thought it was an egregious overreach of power," Dowell said. "It's undermining due process. It's undermining democracy. I was upset, honestly."

Perry, who was on active duty at the time of the shooting, is still awaiting sentencing from a judge. He faces up to life in prison.

Dowell, who said she has the three-term governor politically, said she worried case could cause other jurors to second-guess their decisions. She said the verdict was strictly based on evidence, following 17 hours of deliberation, and politics did not factor in.

"If your governor is coming out and saying you made the wrong decision, that may make you think twice about what you said or what you felt," she told

The AP has attempted to publicly since Abbott, a reach all jurors who served during the weeklong trial in Austin. Others declined to speak about the case or not returned messages.

from feeling any temptation toward corruption.

Intentionally, a code of conduct for federal judges below the Supreme Court requires them to avoid even the "appearance of impropriety."

Members of the high court, Chief Justice John Roberts has written, "consult" that code for guidance.

However, the Supreme Court is left almost entirely to police itself.

And many opine that Thomas has exploited that privilege and, along with his wife Ginny, have thumbed their noses at Democracy.

"The most glaring example of the Supreme Court's ethical vacuum is Clarence Thomas," political columnist Jonathan Chait wrote for New York Magazine.

"The right-wing justice has operated, in conjunction with his wife, in the center of a network of conservative activists whose project is indistinguishable from his legal work."


