WHAT WAS LOST, WHAT WAS SAVED FROM THE NOTRE DAME FIRE?

PARIS (AP) — More than simply an iconic cathedral and jewel of Gothic architecture, Notre Dame was a treasure trove, housing priceless and irreplaceable marvels of immense religious, artistic, musical, historical and architectural value.

Some were lost to humanity forever in the blaze that ravaged the Paris cathedral Monday. Others were spared, at least in part, or saved before the flames consumed the roof and spire.

A look at what is known about Notre Dame's treasures and their fate.

CROWN OF THORNS

Regarded as the cathedral's most sacred relic, Paris Mayor Anne Hidalgo says the Crown of Thorns was saved. It is purported to be a relic of the crown placed on the head of Jesus Christ at his crucifixion, obtained and brought to Paris by King Louis IX in the 13th century. It is made of rushes wrapped into a wreath and tied with gold filament. Since 1896 it has been kept under glass and only occasionally displayed. Paris Deputy Mayor Emmanuel Gregoire said it was among pieces quickly transported to a "secret location" by officials after the fire. Hidalgo also said on Twitter that the tunic of St. Louis, a long shirt-like garment from the 13th century and believed to have belonged to King Louis IX, was

also rescued.

FRAGMENT OF THE HOLY CROSS AND NAIL

The 24-centimeter (9.45-inch) piece of wood and 9-centimeter-(3.5-inch)-long nail are purported to be from the cross on which Jesus Christ was crucified. The wood fragment is kept in a glass case. The fate of the two relics is not known.

THE ORGAN

The impressive organ dating to the 1730s and boasting an estimated 8,000 pipes did not burn and is intact, but nobody knows yet whether it was damaged by the heat or water. "The organ is a very fragile instrument," Bertrand de Feydeau, vice-president of the Fondation du Patrimoine which protects France's cultural heritage, tells The Associated Press. He says the organ has "incredible" sound, with "very rich colors," and there is a waiting list of more than two years of organists wanting to play it. Each pipe was individually cleaned during a 2013 refurbishment.

THE ROOF

The cathedral's roof was built using a lattice of giant beams cut from trees in primeval forests in the 12th and 13th centuries. Experts say France no longer has trees big enough to replace the ancient wooden beams that burned in the Notre Dame fire. Feydeau told France Info radio that the cathedral's roof cannot be rebuilt exactly as it was before the fire because "we don't, at the moment, have trees on our territory of the size that were cut in the 13th century." He said the restoration work will have to use new technology to rebuild the roof

THE BELLS

In the wake of the French Revolution, the cathedral was declared a "Temple of Reason" as part of an anti-clerical movement. All of the original bells were destroyed and replaced — except for one, called Emmanuel and weighing 13 tons. In 2013, as the cathedral celebrated its 850 years with a refurbishment, nine huge new bells replaced the 19th-century ones. The peal of the cathedral's bells has long been famous. Quasimodo was the cathedral's bell-ringer in Victor Hugo's 1831 novel "The Hunchback of Notre Dame." The extent of any damage to the bells and their support structure is unclear.

PAINTINGS

About a dozen large paintings of religious scenes, called "Mays" and dating from between 1630 and 1708, hung in Notre Dame. French Culture Minister Franck Riester says the cathedral's greatest paintings will be removed starting Friday. "We assume they have not been damaged by the fire but there may be damage from the smoke," he said.

STATUES

Last week, 16 religious statues got a lucky escape from Monday's blaze: they were removed from the top of Notre Dame for the first time in over a century to be taken for cleaning. The removal was part of a restoration of the cathedral's towering spire, now gone. The 3-meter-tall copper statues represent the 12 apostles and four evangelists.

STAINED GLASS WINDOWS

The cathedral's three famed rose windows date to the 13th century. The director of the United Nations cultural organization says it's too early to tell whether they are unscathed. Audrey Azoulay tells The Associated Press art experts haven't yet been able to assess the site yet after the blaze, though she has received encouraging reports. Notre Dame is part of a UNESCO heritage site.

The 2019 Masters: Tiger's Incredible Improbable Comeback to Win

After 11 years, multiple surgeries and a myriad of personal drama, Tiger Woods won his fifth Masters Championship and his 15th career major on a sun-soaked Sunday at Augusta National.

It was the first time Woods had won at Augusta after he was trailing after 54 holes.

The victory also came following years of doubting whether he would ever be able to play at a high level.

"It's overwhelming because of what has transpired," Woods told reporters after he shot a -2 under 72 for -13 under overall to seal the victory. "It's unreal for me to be experiencing this. I'm kind of at a loss for words really," he said.

The victory, one of the greatest comebacks in sports history, had social media abuzz.

"The National Newspaper Publishers Association (NNPA) congratulates and salutes Tiger Woods as he wins the Masters Golf Tournament for the fifth time," NNPA President and CEO Dr. Benjamin F. Chavis, Jr., tweeted.

Chavis also noted the tough road Woods had to take to reemerge as Golf's biggest star.

"Resilience is in our DNA," Chavis said, referring to African American and other minorities and certainly acknowledging the challenges overcome by Woods.

Golden State Warriors superstar guard Stephen Curry called Woods' victory, "the greatest comeback story in sports. "Congrats Tiger Woods, let me hold one of those 5 jackets one time," Curry wrote on Twitter.

Tennis great Serena Williams said the win moved her to tears. "I'm literally in tears watching Tiger Woods. This is greatness like no other," Williams Tweeted. "Knowing all you have been through physically to come back and do what you just did today? Wow. Congrats a million times. I am so



inspired. Than you buddy," Williams said.

Former President Barack Obama also offered his congratulations via Twitter.

"Tiger! To come back and win the Masters after all the highs and lows is a testament to excellence, grit, and determination," Obama said.


Fellow golfers like Phil Mickleson, Luke Donaldson, Gary Player and Bubba Watson also tweeted out their respects and congratulations to the 43-year-old Woods.

And, the "Golden Bear," Jack Nicklaus also expressed his appreciation and awe of Woods. "A big 'well done' from me to Tiger Woods," wrote Nicklaus, whose all-time record of 18 Major Championships is certainly within the reach of Woods, who now has 15.

"I am so happy for him and for the game of golf," Nicklaus wrote on Twitter. "This is just fantastic."

To the People of Dallas County,

When I ran to become your District Attorney, I promised you that I would bring changes to our criminal justice system. The changes that I promised will be a step forward in ending mass incarceration in Dallas County, and will make our community safer by ensuring that our limited resources are spent where they can do the most good. My office has made tremendous strides in these last 90 days, and I am proud to announce the following reforms:

First-Offense Marijuana

Although African Americans and people of other races use marijuana at similar rates, in Dallas County African Americans are three times more likely to be prosecuted for misdemeanor marijuana possession than are people of other races. After arrest, African Americans are assessed money bond at a higher rate for marijuana possession, and are assessed higher bond amounts than other races. African Americans are more likely to be convicted of marijuana possession once charged and are more likely to serve a jail sentence.

The District Attorney must take action to end that disparity. To that end, I have declined prosecution on misdemeanor possession of marijuana cases for first-time offenders whose offenses do not occur in a drug-free zone, involve the use or exhibition of a deadly weapon, or involve evidence of delivery. After the first offense, people will be offered a program that, if successfully completed, will keep their record clear. I am also in the process of dismissing all pending misdemeanor marijuana cases filed before I took office, according to the new policy stated above. To date, I have dismissed over a thousand misdemeanor marijuana cases

THC Possession

Prosecution will be declined on State Jail Felony and 3rd Degree Felony Possession of Tetrahydrocannabinol (THC) cases for first time THC offenders whose offenses do not occur in a drug-free zone, involve the use or exhibition of a deadly weapon, or involve evidence of

Trace Amount Drug Possession

No person will be prosecuted in Dallas County for possessing less than .01 grams of drug

Drug Possession Cases without Laboratory Reports

Historically, when an individual is arrested for State Jail and Third Degree Felony drug cases they are taken to jail. The accused may sit in jail for an extended period of time awaiting the

testing of the alleged contraband. My office is returning these cases until the laboratory report is completed. If, in fact, the substance is a controlled substance, we will be requesting that the District Clerk issue a summons instead of a warrant.

Criminal Trespass

Right now, our county jail is the largest mental health provider in the county. However, the jail is not a suitable place for the mentally ill and homeless -- those most often charged with misdemeanor criminal trespass -- whose only crime is not having a place to go. Around 90 percent of homeless individuals charged with trespass will receive an average jail sentence of 33 days. These prosecutions are an ineffective and inhumane approach to dealing with homelessness or mental illness, and yet since 2015, Dallas County has spent nearly \$11 million just to incarcerate those charged with trespass, not including the costs and resources required to arrest and prosecute their cases. To that end, I have instructed my intake prosecutors to dismiss all misdemeanor criminal trespass cases that do not involve a residence or physical intrusion into property. All pending criminal trespass cases meeting these guidelines will be dismissed. and where appropriate will be referred for outpatient mental health services. I urge Dallas County and its municipalities to use the savings to provide affordable housing and mental health services to this vulnerable population.

Theft of Necessary Items

Study after study shows that when we arrest, jail, and convict people for non-violent crimes committed out of necessity, we only prevent that person from gaining the stability necessary to lead a law-abiding life. Criminalizing poverty is counter-productive for our community's health and safety. For that reason, this office will not prosecute theft of personal items less than \$750 unless the evidence shows that the alleged theft was for economic gain.

Driving While License Suspended (DWLI) Prosecuting a person for driving while their license is suspended is often just prosecuting a person for being too poor to pay off their fines and fees. I have developed a diversion program that will result in charges being dismissed for defendants who clear their drivers' licenses.

Misdemeanor Pre-Trial Diversion Expunctions

For those people who have successfully completed our pre-trial diversion program, a conditional dismissal or memo agreement, we will now be proactively expunging the arrest instead of the previous policy of waiting two years for the statute of limitations to run.

Probation

ation was originally intended to be an alternative to incarceration, it is often a on probation much longer than they should be, the system is overtaxed with supervision, and true rehabilitation becomes almost impossible. Our community is not made safer by long probation periods: research shows that probation terms should be only as long as needed to

Senator Doug Jones: IRS Explain Disproportionate Targeting of Minorities for Tax Audits

U.S. Senator Doug Jones (D-Ala.) has sent a letter to Commissioner Charles Rettig of the Internal Revenue Service calling for answers about a recent report that revealed that African Americans are audited by the IRS more than any other group.

Jones also noted a report that showed people in more rural, low-income areas of the country were being audited at disproportionately high rates.

Further, a study of recent audit data suggested that taxpayers in nearly every county in Alabama were audited at a rate higher than the national average, and the rate was even higher in areas of the Black Belt.

"To concentrate so exclusively on this subset of taxpayers defies explanation," Jones wrote in the April 4 letter to the IRS.

"For example, in Greene County, Alabama (population, 8,330), with a median household income of less than \$21,000, it appears that taxpayers are audited over 40 percent more often than the national average, including areas that are much more urban and wealthy," he said.

"For comparison, Bergen County, New Jersey, with a median population of nearly 1 million residents, and a median household income of over \$90,000, has an audit rate that matches the national average," Jones said.

In his letter, Jones called it no anomaly. The chances of an IRS audit seem to correlate nearly exactly with the taxpayer's proximity to either the rural Southeast or, in several stark cases, to Native American reserva-

According to IRS statistics, the annual "tax gap," or the gross gap between total taxes owed and total taxes paid on time was over \$450 billion.

"To take such a large portion of limited IRS resources and to focus them so intensely on rural communities in Alabama and the Southeast makes little fiscal sense. Moreover, the practice appears to be blatantly discriminatory," he said.

In an effort to focus its resources and ensure fair treatment of all taxpayers, Jones said he believes the IRS should undertake a full and thorough review of the policies and practices that led to such a disparate geographic impact of its annual audits.

"Given the overwhelming focus on my constituents in the state of Alabama, I would request you respond to the following questions:

- Does the IRS have any official policy dictating that low-income or rural geographic areas be subjected to increased audit rates?
- Does the IRS, in any manner, consider the tax-

payer's address in determining whether to conduct an audit?

- Has the IRS conducted a study or analysis on the fiscal impact of its current practice of geographically concentrating audits versus the fiscal impact of a system that resulted in more evenly dispersed audits?
- Similarly, has the IRS conducted a study or analysis on the fiscal impact of its current practice concentrating audits in low-income and rural communities versus the fiscal impact of a system that resulted in audits being conducted in geographic proportion to the amount of expected tax revenue?
- Has the IRS conducted a study or analysis on the impact of increasing pre-filing education or tax filing assistance in the communities currently oversampled for tax audits, and the effect this education or filing assistance may have on reducing employee hours spent on subsequent audits?







Texas property tax bill clears Senate over court. big city backlash

AUSTIN, Texas (AP) — A bill designed to limit rapid growth of property taxes in Texas has won its first round of approval in the state Senate.

Gov. Greg Abbott and Republican legislative leaders have made property tax relief a top priority of the legislative session. The bill approved Monday wouldn't reduce property taxes, but would require voter approval if local governments raise rates 3.5% or more. School districts would get an even lower threshold of 2.5%.

Local governments can currently raise rates by as dent debts. much as 8% without an election.

Leaders of Texas' big urban cities oppose the bill. They worry it restricts their ability to raise money for services in education and public safety.

Texas man offered \$200 to beat transgender woman

DALLAS (AP) — Dallas police say a man was offered \$200 to beat a transgender woman in an attack that was recorded as a crowd gathered to holler and watch.

A police affidavit released Monday says the woman accidentally backed into a vehicle before the driver of that vehicle pointed a gun at her and refused to let her leave unless she paid for the damage.

Police say that as a crowd gathered, someone offered \$200 to 29-year-old Edward Thomas to beat the woman, who suffered a concussion, fractured wrist and other injuries.

Waters, Durbin Reintroduce Bill to Give Students Defrauded by For-Profit Colleges Their Day in Court

WASHINGTON – U.S. Representative Maxine Waters (D-CA-43) and U.S. Senator Dick Durbin (D-IL) and have reintroduced bicameral legislation designed to strengthen students' ability to hold forprofit colleges accountable in court for their misconduct. The Court Legal Access & Student Support (CLASS) Act prohibits any school receiving Title IV student aid funding from placing restrictions on students' ability to pursue legal claims, individually or with others, against higher education institutions in

The CLASS Act aims to end the strategic use of mandatory arbitration and class action waiver clauses in enrollment agreements by for-profit colleges. Legitimate non-profit colleges and universities do not include mandatory arbitration clauses in their enrollment agreements, but these clauses are a hallmark of the for-profit college industry. If this bill had been law in the last several years, many students defrauded by Corinthian Colleges and other nowdefunct for-profits would have been able to seek redress directly from their school instead of being forced to seek relief from the taxpayers for their stu-

"The for-profit college industry is rife with bad actors that lure potential students into some of the most expensive academic programs, all while knowingly and fraudulently misrepresenting the quality and success of these programs. These schools use mandatory arbitration clauses and other tactics to shield themselves from being held responsible for their wrongdoing," said Congresswoman Maxine Waters. "I am proud to introduce bold legislation that eliminates mandatory arbitration provisions and ultimately ensures that students have a right to their day in court."

"Mandatory pre-dispute arbitration clauses amount to traps in contractual fine print that hurt people and undermine their ability to seek justice. Predatory for-profit colleges often use these clauses in their student enrollment agreements in order to shield themselves from accountability," said Senator Dick Durbin. "Students who were hung out to dry by deadbeat for-profit schools, with mountains of student loan debt, should be allowed to hold these schools directly accountable in court. That's why I'm reintroducing the CLASS Act which would end this shady practice in for-profit college enrollment agreements."

DFW Airport to start planning 6th terminal for more flights

FORT WORTH, Texas (AP) — Talks are expected to begin this spring on adding a sixth passenger terminal at Dallas-Fort Worth International Airport, the main hub for American Airlines, aviation officials

Airport authorities said there's a good chance

Terminal F could be built with design standards that allow more airplanes to park in a smaller space, the Fort Worth Star-Telegram reported.

Terminal F will probably not be the same shape as other terminals at DFW. Some 60% of DFW passengers are connecting for another flight, and the halfmoon terminal design is not the best shape for connecting customers, said Sean Donohue, DFW Airport chief executive officer.

Suspect Arrested in Case of Three Church Fires in Louisiana By Lauren Victoria Burke, **NNPA Newswire Contribution**

St. Mary Baptist Church in Port Barre burned down on March 26. On April 2, the Greater Union Baptist Church in Opelousas, Louisiana was burned down. Two days after that fire on April 4, the Mount Pleasant Baptist Church was also burned in the same town. Authorities are confident that the fires were all intentionally set.

A 21-year-old named Holden Matthews has been arrested in connection with fires at three predominantly Black churches in Louisiana. All three churches were destroyed. Matthews' social media accounts evidenced loose connections with white supremacy.

Members of the Congressional Black Caucus asked for the FBI to investigate the arsons as a hate crime.

Cosby's insurer settles LA accuser's suit before deposition By MARYCLAIRE DALE

PHILADELPHIA (AP) — Bill Cosby's insurance company has settled another lawsuit filed by a female accuser a week before the imprisoned comedian was set to give a deposition in the case, prompting Cosby to call the insurer "complicit" in a scheme to destroy him.

Former model Chloe Goins had accused Cosby of drugging and molesting her at a party at the Playboy Mansion in Los Angeles in 2008, when she was about

Cosby in a statement Tuesday accused American International Group Inc. of "egregious behavior" in settling what he called a "frivolous" suit, and said he could prove he was in New York at the time. Goins' lawsuit was filed in state court in Los Angeles.
