

munications director, also stepped down. Prominent news reports suggested major issues between the White House and Vice President Harris' staff, but officials have dismissed such claims.

The daughter of Omaha Publisher Terri Sanders, Symone Sanders earned acclaim as "a champion for women."

A seasoned political strategist, Sanders gained national prominence in 2016 as the National Press Secretary for U.S. Sen. Bernie Sanders' then-presidential campaign.

At 25, she became the youngest presidential press secretary on record and was named to Rolling Stone Magazine's list of 16 young Americans shaping the 2016 election.

Sanders also worked as the principal of the 360

Group LLC, providing strategic communications guidance to organizations, businesses, individuals, campaigns and candidates and helps clients find sound solutions to tough political and social problems.

According to her biography, Sanders counts as "a communicator with a passion for juvenile justice," and served as the former chair of the Coalition of Juvenile Justice Emerging Leaders Committee and former member of the Federal Advisory Committee on Juvenile Justice.

She worked diligently to raise the profile of young voices in the fight for juvenile justice reform and bring millennial perspectives to policy conversations.

Sanders, 31, once worked as a political com-

mentator for CNN and served in 2018 and 2019 as resident fellow Harvard's Institute Politics at the Kennedy School and the University of Southern California's Center for the Political Future respectively.

"Symone has been working at the highest levels and extraordinarily an intense environment for three years for Joe Biden and now Vice President Harris," Anita Dunn, a former top aide to President Joe Biden, said in a televised interview this week.

"When you look at the three years, two on the campaign, one in the White House, nobody can question her decision that she needs a break and it's time to move on. And she'll always be a member of the Biden-Harris family," Dunn asserted.

"THE HEALING OF THE LAME MAN"

ACTS 3:1-10

By Rev. Johnny Calvin Smith



We are not told how long after the events of Pentecost that the incident of the text took place. Whatever the amount of time, the believers continued to be active in their faith in spreading the good news. As a part of their religious customs, we find in our text Peter and John engaged in worship in the temple. Our text says that Peter and John entered the temple courts at the

ninth hour which is 3:00p.m. (v.1).

As Peter and John entered the temple, a lame man was placed there, who daily asked contributions from the crowd of worshippers. This lame man simply wanted a contribution to supply his needs (vv. 2-3). He sat daily at the gate called beautiful to ask alms of worshippers. The gate called beautiful was a gate that led from

the court of the Gentiles into the temple area limited to Jews. As people poured through the gate, no doubt this lame man became a noticeable object as he sat begging for alms.

What a pitiful picture we have of an individual who is both helpless and hopeless. The lame man serves as a portrayal of a lost sinner – one who is helpless and hopeless. As believers, we need to

extend a helping hand, directing the lost to Jesus Christ, the Saviour of mankind (St. John 1:29; 6:35). The lame man of our text, who had a handicap, was instructed by Peter to gaze at both Peter and John (v. 4). Having obeyed Peter's instructions, the lame man was expecting only a contribution (v. 5). This man who had been crippled for over forty years (Acts 4:22), never imagined

that the power of God could bring relief to his crippled condition.

To remedy his lame situation, Peter and John did not offer the lame man material substance, but invoked the powerful name of Jesus for verse 6 says, "Then Peter said, Silver and gold have I none; but such as I have give I thee: in the name of Jesus Christ of Nazareth rise up and walk." At the powerful name of Jesus, this once lame man received a cure (v. 7). This man's condition was indeed helpless and hopeless but he received strength to walk because of the power of Jesus! Having been healed, beggar the

expresses jubilation by walking, leaping and praising God (v. 8).

The man, who once lay at the gate, is now expressing unusual joy in the temple as he praises God. After one has been healed by Jesus, he or she should have a desire to worship Him where other worshippers go. This miracle of the healing of the lame man was a noteworthy one and it caused amazement among many people, because they knew of the helpless condition of the lame man (vv. 9-10). When God truly heals one, it is truly amazing!

CNN fires **Chris Cuomo for** helping brother deal with scandal

NEW YORK (AP) — CNN fired anchor Chris Cuomo on Saturday less than a week after new information emerged about how he assisted his brother, former New York Gov. Andrew Cuomo, as the politician faced sexual harassment allegations earlier this year.

The network had suspended its prime-time host on Tuesday to investigate his conduct, after New York's attorney general released details showing he was more involved than previously known in helping to strategize and reach out to other journalists as his brother fought to keep his job.

Justice Department sues Texas over new redistricting maps

AUSTIN, Texas (AP) — The Justice Department sued Texas on Monday over its new redistricting maps, saying the plans discriminate against minority voters, particularly Latinos, who have fueled the state's population

The lawsuit claims the Republican-controlled state violated part of the Voting Rights Act in drawing new district boundaries for its congressional delegation and state legislature. It's the Biden Justice Department's first legal action challenging a state's maps since states began redrawing their maps this year to account for population changes.

The lawsuit notes that most of Texas' population growth over the past decade came from Black, Latino and Asian people, but alleges that the new maps scatter these voters across districts, diluting their votes and denying them opportunities to choose their representatives. It also argues the maps pack Black and Latino communities into bizarre-shaped districts — a Dallas-area one is described as "seahorse" shaped — while preserving seats for white Republicans.

"This is not the first time that Texas has acted to minimize the voting rights of its minority citizens," Associate Attorney General Vanita Gupta said during a news conference with Attorney General Merrick Garland. "Decade after decade, courts have found that Texas has enacted redistricting plans that deliberately dilute the voting strength of Latino and Black voters and that violate

the Voting Rights Act."

The litigation comes as Republicans and Democrats jockey for an edge in the once-a-decade redistricting process, which has already reached new levels of gerrymandering. The lawsuit also plays out during a changed legal landscape for redistricting challenges. The U.S. Supreme Court ruled in 2019 that it won't referee partisan gerrymandering disputes political party.

Republican, condemned the lawsuit.

"It's no surprise that Democrats in Washington are attacking our state's redistricting plans," Renae Eze said. "We are confident that Texas' redistricting plans will be upheld by the courts, and our office continues working with the Office of the Attorney General to ensure Texans are represented fairly."

Monday's lawsuit, filed in the Western District of Texas, cites several congressional districts in which Republicans drew tortured lines to lower the share of Black and Latino voters in their party's congressional districts.

In west Texas' competitive 23rd District, the map trimmed out areas near El Paso and San Antonio to lower the share of Latino voting-age residents by 9%. In the Dallas area, it pulled Black and Latino residents in the northwest suburbs out of the district of Republican Rep. Beth Van Duyne, who narrowly defeated Candace

Black Latina candidate last year. In the Houston area, where the share of the white population is dwindling, the map kept six of 10 House districts as white-majority or plurality districts.

Texas has had to defend its maps in court after every redistricting process since the Voting Rights Act took gressional effect in 1965. But this will be the first time since a 2013 maps drawn to benefit a U.S. Supreme Court ruling gutted a provision of the A spokeswoman for Texas Voting Rights Act that had Gov. Greg Abbott, a required Texas and other states with a history of racial discrimination to have the Justice Department approve the maps before they went into effect.

The case is the second civil rights lawsuit the Biden administration has filed against Texas recently. Last month, it sued to overturn the state's new voting law, part of a wave of GOPbacked voting changes, claiming the new restrictions would disenfranchise citizens in the state.

The lawsuit, and others that civil rights groups and Democrats have previously filed challenging Texas' maps, may not change things before next year's election. Redistricting litigation can take several years and the Biden administration case will be heard in the 5th Circuit Court of Appeals, one of the most conservative in the country.

Valenzuela, a Democratic hibits line-drawers from diluting the voting power of minorities by scattering them among districts and preventing them from choosing their preferred candidates.

"The Legislature refused to recognize the state's growing minority electorate," the lawsuit alleges. "Although the Texas condelegation expanded from 36 to 38 seats, Texas designed the two new seats to have Anglo voting majorities."

The lawsuit notes that Texas' congressional map was drawn with heavy input from its Republican congressional delegation, which is all white except for one representative. Latino Statehouse Democrats at the time objected strongly to the process and the results.

Although the federal lawsuit alleges Black voters are also treated improperly by the map, the bulk of the case centers around the map's treatment of Latinos.

The focus on Latinos could complicate the case. To prove that Latinos were denied their choice, the government has to prove that they vote as a bloc, and not in line with the majority of the voters in the district. While most Latinos in Texas vote Democratic, many have shifted to Republicans recently, with President Donald Trump gaining ground in 2020.

"That does complicate the narrative," said Blackman, a law professor at the South Texas College of Law in Houston, noting that

Pfizer says COVID booster offers protection against omicron

Pfizer said Wednesday that a booster of its COVID-19 vaccine may offer important protection against the new omicron variant even though the initial two doses appear significantly less

effective. Pfizer and its partner BioNTech said that while two doses may not be strong enough to prevent infection, lab tests showed a booster increased by 25-fold people's levels of antibodies capable of fighting off omicron. For people who haven't yet had a booster, the companies said two doses still should prevent severe disease or death.

Health authorities in the U.S. and other countries have urged eligible people to get a third dose even before these results.

"Go and get your third boost as soon as possible," Dr. Mikael Dolsten, Pfizer's chief scientific officer, told The Associated Press. "This is comforting and a very positive message that we now have a plan that will induce immunity that is likely to protect from infection, symptomatic illness and severe disease from now across the entire winter season."

President Joe Biden said the Pfizer booster finding is

encouraging" although he cautioned, "that's the lab report.

Pfizer and BioNTech tested blood samples taken a month after a booster and found people harbored levels of omicron-neutralizing antibodies that were similar to amounts proven protective against earlier variants after two doses. For the lab tests, researchers grew samof so-called "pseudoviruses" that hold the worrisome new muta-

Scientists don't yet know how big a threat the omi-



cron variant really is. Currently the extra-contagious delta variant is responsible for most of the COVID-19 cases in the U.S. and other countries.

But the omicron variant, discovered late last month, carries an unusually large number of mutations and scientists are racing to learn how easily it spreads, whether it causes illness that is more serious or milder than other coronavirus types — and how much it might evade the protection of prior vaccinations.

Pfizer's findings, announced in a press release, are preliminary and

haven't yet undergone scientific review. But they're the first from a vaccine maker examining whether the booster doses that health authorities are urging peoa key difference.

Moderna and Johnson & Johnson also are testing how their vaccines may hold up, but health authorities will be closely watching for real-world evidence of how omicron spreads in highly vaccinated popula-

If it becomes dominant and causes serious illness, then regulators will have to decide whether vaccines should be tweaked to better match omicron — changes to the recipe that manufacturers already are beginning, just in case.

Scientists have speculated that the high jump in antibodies that comes with a third dose of current COVID-19 vaccines might be enough to counter any decrease in effectiveness.

Despite the large number ple to get may indeed make of mutations that omicron bears, "it is still not a complete escape variant, it is a partial escape variant," BioNTech CEO Ugur Sahin said in a press conference.

Antibody levels predict how well a vaccine may prevent infection with the coronavirus but they are just one layer of the immune system's defenses. Pfizer said two doses of the vaccine should still protect against severe disease, because omicron's mutations don't appear to hamper another defense — T cells that fight the virus after infection sets in.



A small lab study in South Africa also concluded people may be more susceptible to breakthrough omicron infections after just two Pfizer doses. Scientists from the Africa Health Research Institute in Durban found a sharp drop in antibody strength against omicron compared to other variants — although they didn't test boosters. Pfizer boosters aren't yet available in South Africa, but health care workers are being offered extra doses of the singleshot J&J vaccine.

The preliminary South African results suggested people vaccinated after an earlier bout of COVID-19 retained more protection reflecting that initial shots are known to trigger a huge antibody jump after prior infection.

Even if there are more University

breakthrough infections after two doses, most experts believe vaccines will still work against the omicron variant because of the other immune defenses they trigger, said Willem Hanekom, a co-author of the South African study.

"The more antibodies you can have on board, the better you will do, at least in these lab experiments," Hanekom said. "So booster vaccines might be very important."

A U.S. expert agreed the preliminary booster findings are encouraging although more information is needed.

But if omicron winds up causing severe disease and becomes common globally, "it may be much better addressed through vaccines that are adjusted to specifically protect against that variant," said Dr. Jesse Goodman of Georgetown
