PLC's financial approach lowers the barrier to entry for all students interested in receiving an education, as corporate collaborators, like Cadillac, fund masterclasses, tuition and housing for students.

"We are both grateful to Cadillac for its contribution toward diversifying the design industry and for providing support to the next generation of creative talent," said Dr. Edwards. "In a city well known for both design and automotive manufacturing, we are proud to have Cadillac as a supporter in this incredibly important effort that will literally change the face of the entire design industry."

"Raising awareness for creative careers, from early education, to trades, to colleges and universities, is a key focus for General Motors' Design team," said Crystal Windham, GM executive director, Industrial Design. The winning bidder will have the opportunity to design a pair of custom sneakers with Dr. Edwards that will be manufactured as a one-of-one run and will also receive an exclusive signed and framed 12 x 18-inch design-studio theme sketch of the 2023 Cadillac Escalade-V by Robert Hunwick, the lead exterior designer for the Escalade-V.

The 2023 Escalade-V is the third Cadillac V-Series auction at Barrett-Jackson since 2021. Previous auctions include the first production Cadillac V-Series Blackwing sedans and the CT5-V Blackwing 120th Anniversary edition.

Rihanna Listed by Forbes as World's Youngest Self-Made Billionaire

The singer and entrepreneur, whose Fenty Beauty line counts among the most popular in the world, is the only billionaire under 40 on Forbes' list.

In 2021, Rihanna achieved billionaire status.

In 2022, Forbes acknowledged that the Barbadian beauty now counts as the youngest self-made billionaire in America.

The 34-year-old, who at about \$3 billion. recently gave birth to her first child, ranked 21st overall in the latest Forbes list of billionaires. Beauty, reportedly

Earlier this year, reports noted that Rihanna's Savage X Fenty lingerie planned an initial public offering valued at about \$3 billion.

The megastar owns 30 percent of Savage X Fenty and 50 percent of Fenty Beauty, reportedly generating \$550 million in revenue in 2020.

The nine-time Grammy

Award winner has stated that she intends to increase her philanthropic efforts around the globe.

"My money is not for me; it's always the thought that I can help someone else," she told the New York Times in 2021. "The world can really make you believe that the wrong things are priority, and it makes you really miss the core of life, what it means to be alive."

In 2021, Forbes estimated Rihanna's net worth at \$1.7 billion, trailing only Oprah Winfrey as the world's richest entertainer.

"A lot of women felt there were no lines out there that catered to their skin tone. It was light, medium, mediumdark, dark," Shannon Coyne, co-founder of consumer products consultancy Bluestock Advisors, told Forbes about Rihanna's successful beauty products.

"We all know that's not reality. She was one of the first brands that came out and said, 'I want to speak to all of those different people.""

Born Robyn Rihanna Fenty on February 20, 1988, in Saint Michael, Barbados, the tantalizing starlet delivered hit after hit with songs like "Umbrella," "Rude Boy," and "Diamonds." With over 100 million social media followers, Rihanna's fans have pleaded with their idol to deliver new music.

But with her Fenty and Savage X Fenty business white-hot, Rihanna appears to have settled in as an entrepreneur and business magnate.

Cutting deals with Puma in 2014, Dior in 2016, Fenty Beauty in 2017, Savage X Fenty in 2018, and Fenty Skin in 2020, Rihanna kept her business focused.

Forbes writer Madeline Berg described Rihanna's rise this way:

"When Robyn Fenty, known to the world as Rihanna, launched Fenty Beauty in 2017, she sought to create a cosmetics company that made "women everywhere (feel) included." A perhaps unintended consequence: The beauty line has helped her enter one of the world's most exclusive ranks: Billionaire."

Berge concluded by providing commentary from Coyne, the consultant.

"She is creating a brand outside of herself. It's not just about Rihanna. Even if you don't like her music, she's created a real style in the fashion and beauty space."

"THE SECOND MISSIONARY JOURNEY OF PAUL PAUL AND SILAS JAILHOUSE EXPERIENCE"

ACTS 16:1-40

As chapter 15 concluded, we discover that Paul and Silas "went through Syria and Cilicia, confirming the churches" (v. 40). From Syria and Cilicia, they will go up into Galatian country. Paul will visit the Galatian churches because of the problem that had arisen with the Judaizers. Paul will address this problem of the Judaizers in the book of Galatians because the Judaizers were leading the

Galatian believers astray by trying to put the Galatian believers under the Mosaic system. In the book of Galatians, Paul will unfold a sturdy defense of the doctrine of justification by faith. In other words, a man is justified solely by grace through faith without the keeping of the Law! Grace is a way to life and a way of life!

As chapter 16:1-2 opens, Paul arrives at

Derbe and Lystra, and at Lystra, he meets Timotheus (Timothy). Timothy is now with the missionary team of Paul and Silas. In verse 3, Paul has Timothy circumcised because Paul didn't want any degree of offense, or argument as Timothy carried the gospel to Jewish synagogues. There was simply no merit in circumcision but Paul didn't want circumcision to be an issue! Paul had Timothy

circumcised so Timothy's ministry among the Jews would not be handicapped.

As the missionary team of Paul, Silas, and Timothy traveled from town to town, they delivered the decisions reached by the Jerusalem Council (Acts 15:23-29). As they visited the churches, Paul and his team had tremendous spiritual success (vv. 4-5). After Paul had gone and his missionary team through Phrygia and the

region of Galatia, Paul was forbidden of the Holy Spirit to preach the word in Asia (v. 6). After Paul goes to Mysia, he was forbidden to go Bithynia but goes to Troas (vv. 7-8). From Troas, Paul will receive his Macedonian call, for the gospel is going across from Asia into that Europe (v. 9). From verse 10, Dr. Luke joins the missionary team of Paul, Silas and Timothy. Leaving Troas, the team came to Samothracia, Neapolis and then to Philippi (vv. 11-13). In Philippi, Paul and his team came into contact with Lydia, the first convert to Christ in Europe. Her whole household was saved (vv. 14-15).

From verses 16-24, Paul encountered a demon possessed girl who had brought her masters much gain. Paul cast out the demon in the girl, resulting in Paul and Silas being severely beaten. From verse 25, Paul and Silas are in jail at midnight, engaged in "prayer and singing praises unto God." As Paul and Silas were rendering praises unto God, suddenly the earthquake shakes the jail, the doors were opened, and the jailer opens his heart to receive Christ as Saviour (vv. 26-31). The Philippian jailer's household was also saved (vv. 32-34). Chapter 16 closes with the magistrates apologizing to Paul and Silas for severely beating them (vv. 35-40).

to their children."

In an initial statement Sunday, Sesame Place said the park and its employees stand for "inclusivity and equality in all forms." The statement also noted that performers sometimes miss requests for hugs because the costumes they wear make it difficult to see at lower levels.

"The Rosita performer did not intentionally ignore the girls and is devastated by the misunderstanding," the statement said.However, many people expressed outrage online and some called for a boycott of the amusement park.

The park issued a second statement Monday, apologizing again and promising that it was "taking action to do better." Among those efforts would be inclusivity training for employees.

Both statements and the video triggered a stark response on social media, which LaMarr said helped shed a light on "the existence of these issues."



recognizing its outer coating, the spike protein -- and the first three options essentially turn people's cells into a temporary vaccine factory. The Pfizer and Moderna vaccines deliver genetic instructions for the body to make copies of the spike protein. The lesser-used Johnson & Johnson option uses a cold virus to deliver those instructions.

In contrast, the Novavax vaccine injects copies of the spike protein that are grown in a lab and packaged into nanoparticles that to the immune system resemble a virus. Another difference: An ingredient called an adjuvant, that's made from the bark of a South American tree, is added to help rev up that immune response.

Protein vaccines have been used for years to prevent other diseases including hepatitis B and shingles. HOW WELL IT WORKS

Large studies in the U.S., Mexico and Britain found two doses of the Novavax vaccine were safe and about 90% effective at preventing symptomatic COVID-19. When the delta variant emerged last summer, Novavax reported a booster dose revved up virus-fighting antibodies that could tackle that mutant.

Typical vaccine reactions unanimously endorsed the

were mild, including arm pain and fatigue, but regulators did warn about the posibility of a rare risk, heart inflammation, that also has been seen with the Pfizer and Moderna vaccines, mostly in teen boys or young men.

But early on, manufacturing problems delayed the Novavax vaccine — meaning the shots were studied long before the omicron variant hit, so it's not clear how well they hold up against the immune-evading mutant.

Still, Novavax points to lab testing that shows the first two shots do spur production of virus-fighting antibodies that are crossprotective against omicron, including the BA.5 subtype that's currently the nation's top threat. A booster dose further revved up cross-protective antibodies.

HOW TO USE NOVAVAX SHOTS

The CDC's advisers manimously endorsed the two-shot primary series. But several noted that it was important for regulators to clear a booster by the time, five or so months after their last dose, that Novavax recipients will need one.

Also, the two doses typically are given three weeks apart. But CDC officials said that like with other COVID-19 vaccines, it's possible to wait up to eight weeks for the second dose — except for people at the highest risk, who need protection quickly.

WHAT HAPPENS NEXT

Walensky signed off on recommendations for adults to get the first two Novavax doses. In its first purchase, the U.S. government bought 3.2 million doses and vaccinations are expected to begin in the next few weeks. The Novavax vaccine also is used in Europe, Canada, Australia, South Korea and other countries. Many allow booster doses, and European regulators recently cleared the shots to given as young as age 12.

The Maryland-based company likewise expects U.S. authorization of a booster dose and teen vaccinations to follow fairly soon. And like other vaccine makers, Novavax is testing shots updated to better match the newest omicron subtypes -- in anticipation of another round of boosters this fall and winter. "A lot of African Americans tend to become very passive because we unfortunately are accustomed to dealing with this type of racism in various spaces," he said.

Sesame Place has been the official "Sesame Street" theme park for more than four decades. It opened in 1980.

"You would expect a reputable organization the one as well revered as Sesame Street and Sesame Place to stand on those principles and values in which they portray," LaMarr said. "Instead, what this family saw was a company that comes out and they're very dismissive of the harms that were caused."



and Secretary of State Antony Blinken have said they are doing all they could to win her release, as well as that of other Americans the U.S. considers "wrongly detained" by Russia, including former Marine Paul Whelan who is serving 16 years on an espionage conviction.

Washington may have little leverage with Moscow, though, because of strong animosity over its military operation in Ukraine.

"In the hearings yesterday and today what became very clear is the tremendous amount of respect and admiration both in the United States and here in Russia where Miss Griner has been playing basketball for seven years, not only for her professional achievements but for her character and integrity," U.S. Embassy charge d'affaires Elizabeth Rood said outside the courthouse in the Moscow suburb of Khimki, where the airport is located. The director and team captain of UMMC Ektaerinburg testified on her behalf on Thursday.

Bout's release for years. But the wide discrepancy in the seriousness of their cases could make such a trade unpalatable to Washington. Others have suggested that Griner could be traded along with Whelan, who is serving 16 years in Russia on an espionage conviction that the U.S. has described as a setup.

The State Department's designation of Griner as wrongfully detained moves her case under the supervision of its special presidential envoy for hostage affairs, effectively the government's chief hostage negotiator. The classification has irritated Russia.

Asked about the possibility of Griner being swapped for a Russian jailed in the U.S., Deputy Foreign Minister Sergei Ryabkov, the senior Russian diplomat, has noted that until her trial is over "there are no formal or procedural reasons to talk about any further steps." Ryabkov warned that U.S. criticism, including the description of Griner as wrongfully detained and dismissive comments about the Russian judicial system, "makes it difficult to engage in detailed discussion of any possible exchanges." Griner's detention has been authorized through Dec. 20, suggesting the trial could last months. Griner's lawyers, however, said they expect it to conclude around the beginning of August.

KHIMKI, Russia (AP) — A lawyer for WNBA star Brittney Griner at her drug possession trial in Russia on Friday gave the court a U.S. doctor's letter recommending she use medical cannabis to treat pain.

Griner, a two-time Olympic gold medalist and standout for the Phoenix Mercury, was arrested at Moscow's Sheremetyevo Airport in February after customs officials said they found vape canisters containing cannabis oil in her luggage. She faces up to 10

years in prison if convicted on charges of transporting drugs.

In court last week, Griner pleaded guilty and acknowledged possessing the canisters but said she had no criminal intent and said they were in her luggage because she packed hastily in her return to Russia to play for the UMMC Ekaterinburg basketball team during the WNBA's offseason.

In Russia's judicial system, admitting guilt doesn't automatically end a trial. Since that plea, her court sessions have focused on inperson and written testimony to her good character and athletic prowess.

Griner wore a Nirvana Tshirt as she sat inside the defendant's cage that is customary in Russian courtrooms. At one point, she held up a photo of fellow WNBA players wearing her name and No. 42 on their uniforms in tribute during part of Sunday's All-Star Game in Chicago.

"The attending physician gave Brittney recommenda-

tions for the use of medical cannabis," said her lawyer, Maria Blagovolina. "The permission was issued on behalf of the Arizona Department of Health."

Medical marijuana is not legal in Russia.

The defense on Friday also submitted tests she underwent as part of an anti-doping check, which didn't detect any prohibited substances in her system.

The next hearing of Griner's case was scheduled for July 26.

Russian media have speculated that Griner could be swapped for Russian arms trader Viktor Bout, nicknamed "the Merchant of Death," who is serving a 25-year sentence in the U.S. after being convicted of conspiracy to kill U.S. citizens and providing aid to a terrorist organization.

and we have taken significant action to protect the sanctity of life," the Republican governor said in a June 24 statement. "Texas has also prioritized supporting women's healthcare and expectant mothers in need to give them the necessary resources so that they can choose life for their child."

Abbott's statement neglected to mention that Texas lags behind at least 33 states, including 11 led by Republican governors, as well as the District of Columbia, all of which have already expanded or are working with the federal government to extend postpartum Medicaid benefits for a full year after giving birth. In 2021, the Texas House passed a measure that would have lengthened that coverage to 12 months, but

during the waning days of the legislative session one of the senators who coauthored the state's restrictive abortion law halved the time period.

Texas is among a dozen states that have also declined to expand broader Medicaid coverage under the Affordable Care Act to additional people with low incomes, leaving it with some of the strictest eligibility requirements in the country. For example, single parents with one child must earn \$196 or less a month to qualify.

"It is such hypocrisy," Adrienne Lloyd, a senior health policy associate for the Children's Defense Fund Texas, said about the contrast between state legislators' battle against abortion access and the services they provide to pregnant people. "If you really care about that health and safety, then the pregnant person and baby will have so much better outcomes if they're covered long before and after giving birth."

The state's Maternal Mortality and Morbidity Review Committee recommended extending postpartum Medicaid to one year in a 2020 report that showed cardiovascular and coronary conditions, along with mental disorders, were the leading causes of deaths related to pregnancy. Nearly a third of 54 deaths determined to be directly tied to pregnancy occurred between six weeks and 12 months after birth, the committee found as part of an analysis of 2013 data, the most recent available.

Medicaid is the most comprehensive federal- and state-funded health coverage offered to pregnant people and new parents. The assistance, which is generally available to people with low incomes or with disabilities, has higher income thresholds for those who are pregnant. Medicaid covers hospital visits, specialist care and X-rays that are not provided by other Texas programs.

Extending the eligibility period is critical, said Dr. Carla Ortique, a gynecologist and vice chair of the review committee, because treatments for many of the primary causes of pregnancy-related deaths, such as postpartum depression and cardiomyopathy, take time to work.

"It makes a difference in your outcomes and has been shown to make a difference for future pregnancies," Ortique said.

What we can do, however, is assure that they are privileged to a strong spiritual base so that the decisions they make pass through what I will term the God filter.



Gates Foundation to Spend Additional \$3B Each Year on Several Causes

Bill Gates insists he's optimistic about the future.

One of the wealthiest men in the world said he sees incredible heroism and sacrifice all over the globe, especially as the Covid-19 pandemic continues.

"Medical workers put in unbelievable hours at great risk to themselves to help people infected with COVID. Incredible efforts are taking place to help refugees from the Ukrainian war and to help those caught in battle zones," Gates wrote on his personal blog.

"Activists are courageously protesting and often risking their lives to protect people's rights. People on the front lines inspire me to do whatever I can. Although each of us can only do so much, when lots of people join in, we will resume progress."

This week, the Bill and Melinda Gates Foundation announced it would significantly increase its already robust philanthropic efforts in areas including global health, economic development, gender equality, and education.

The world's largest charitable foundation will increase the rate of its grantmaking from nearly \$6 billion to \$9 billion each year by 2026.

Among its many efforts,the foundation sponsors theNationalNewspaperPublishersAssociation(NNPA) education program.

"We need all sectors of society – government, the private sector, and the nonprofit sector, including philanthropy – to engage on these issues," Gates insisted. "Philanthropy is the smallest of these sectors, but it is unique in its ability to try risky ideas that can have a large impact if they succeed and are scaled up."

Despite the 2021 announcement that Gates and his wife, Melinda French Gates, were divorcing, the couple has continued to make the foundation and charitable giving a primary focus.

"I am putting a lot of my energy and resources into innovators working on pandemic prevention, global health, climate mitigation (including getting rid of dependence on hydrocarbons) and adaption, education, improvement (including remediation), and food costs.

"When I say 'innovation,' I'm referring to new products and services as well as new ways of delivering them to those in need – including by strengthening local leaders and institutions," Gates continued.

"These innovations will not come in time to avoid the problems altogether, but the faster we move, the less people will suffer. For many people, including myself, this is the most concrete way of contributing, even when it seems modest compared to the scale of the problems. Focusing on being part of the solution is better than giving up in despair."

According to the New York Times, Gates and French Gates promised to inject an additional \$15 billion in funds into the foundation a year ago. Gates said that as part of that commitment, he planned to give \$20 billion to the foundation this month.

"As I look to the future, my plan is to give all my wealth to the foundation other than what I spend on myself and my family," Gates wrote this week.

"I will move down and eventually off of the list of the world's richest people," added Mr. Gates, who, along with French Gates, has already given \$39 billion to the foundation since 1994.

"My giving this money is not a sacrifice at all. I feel privileged to be involved in tackling these great challenges," Gates insisted.


I'm particularly excited to rejoin a community that is so deeply focused on providing excellence and equity in education for
