Texans face skyrocketing home energy bills as the state exports more natural gas than ever

The cost of electricity in Texas is tightly tied to the price of natural gas, which has more than doubled since Russia invaded Ukraine in late February.

Texans are seeing skyrocketing home electric bills this spring and summer, with many customers paying at least 50% more than they did for electric bills at this time last year.

And nobody seems to know when costs will go down.

"I am worried people are going to be shocked," said John Ballenger, vice president at Texas retail electric provider Champion Energy. "Realizing this is 50 or 60 or 70% higher than what they had paid before, I'm just not sure it's real to people yet. If it's not, it will be very, very

soon when the bills hit this summer."

Here's what Texans need to know about why utility bills are getting more expen-

What's driving electricity and gas bills higher?

The elevated utility bills have primarily been driven by the price of natural gas, which has shot up more than 200% since late February when Russia, a top gas-producing country, invaded Ukraine and upended the world's energy market.

Gov. Greg Abbott's lead over Beto O'Rourke narrows to 6 points, poll finds

Republican Gov. Greg Abbott's lead Democratic challenger Beto O'Rourke narrowed to 6 points last month, according to a poll conducted by the Texas Politics Project at the University of Texas at Austin. That's a smaller gap than when Republican George W. Bush ousted Democrat Ann Richards in 1994 with a 7.6-point win.

Abbott's unfavorability ratings are also the highest they've ever been at 44%, according to the poll, which was conducted after the deadliest school shooting in state history and almost entirely before the U.S. Supreme Court overturned the constitutional right to an abortion.

After Buffalo, civil rights leaders pitch anti-hate plans

NEW YORK (AP) — The nation's oldest civil rights organization said it will propose a sweeping plan meant to protect Black Americans from white supremacist violence in response to a hate-fueled massacre that killed 10 Black people in Buffalo, New York, last weekend.

In a plan first shared with The Associated Press, the NAACP suggests a policy approach to stopping future acts of anti-Black domestic terrorism that involves law enforcement, business regulation and gun control. The proposal points to measures that could be taken up immediately by the Department of Justice and Federal Trade Commission.

Specifically, the plan calls for holding accountable any corporation that is complicit in the spread of bigotry and racism through news media and on social platforms, for enacting gun violence prevention measures that keep mass-casualty weapons out of the hands of would-be assailants and for reforming police practices so Black Americans experience the same de-escalation tactics often used to peacefully apprehend murderous white supremacists.

Saturday's premeditated attack by an avowed racist on Black shoppers at the Tops Friendly Market in Buffalo made it clear that "democracy and white supremacy cannot co-exist," NAACP President and CEO Derrick Johnson said.

with Attorney Merrick Garland on Friday, a spokesperson for the civil rights group said.

The NAACP revealed its proposal as Black leaders across the country fret about inaction on the part of elected leaders to prevent domestic terror attacks by white supremacists against Black Americans. From Tulsa, Oklahoma, Birmingham, Alabama, to Charleston, South Carolina, Charlottesville, Virginia, generations of Americans have not seen the rising death toll from such violence met with urgent legislation to prevent or reduce the threat.

The Ku Klux Klan bombing that killed four Black

girls at the 16th Street **Baptist** Church Birmingham helped spur passage of the Civil Rights Act of 1964 — historic legislation that outlawed segre-Klan's violence.

It did not address excessive uses of police force on peaceful demonstrators.

And it had been 67 years after the murder of Emmett Till, a black teen from Chicago who was kidnapped in Mississippi, lynched and dumped in a river after he was accused of whistling at a white woman, before Congress enacted an antilynching law. President Joe Biden signed the bill in late March, more than a year after using his inaugural speech to warn of the rise in white supremacist ideology and domestic terrorism.

"White supremacy is a

poison," Biden reiterated Tuesday during a visit to Buffalo. "We need to say as clearly and forcefully as we can that the ideology of white supremacy has no place in America."

As the coronavirus pandemic gave rise to anti-Asian hate crimes, Congress quickly enacted legislation that encourages reporting of such crimes. It also gave law enforcement more resources to handle increased report-

But now, in the wake of the white supremacist attack in Buffalo, Black civil rights advocates are wondering if they'll see the same haste from lawmakers on anti-Black hate crimes. The House passed legislation late Wednesday night that would bolster federal resources to prevent domestic terrorism in response to the mass shooting. Supporters of the House bill say it will help officials better track and respond to the growing threat of white extremist tergation. It did not address the rorism. But the bill still has to receive approval from the

> "We need to know that our top leaders in America react and respond when we are hurt, too, like they acted and responded when others were hurt," said prominent Crump, who represents the family of 86-year-old Ruth Whitfield, the eldest victim to die in the Buffalo attack.

> Andrea Boyles, an associate professor of sociology and Africana studies at Tulane University, said part of the Black experience in America is seeing racialized violence against Black communities treated as a nonurgent matter.

"The message of it all has consistently been that where there is hate towards Black people, there is least likely to be consequences," Boyles said. "We should be clear with elected officials, Black

How long will Texans see higher utility bills?

With the war in Ukraine dragging on and upending the world energy market, Texas electricity providers are cautioning customers that the high rates could linger for months or longer. The higher prices will, however, benefit some Texans. As a major gas producer, the state typically benefits from high oil and gas prices in the form of jobs and state taxes on oil and gas production. Cities located in the state's oil fields usually benefit

"I grew up in Odessa in the middle of oil and gas, and there's always been this inverse relationship," said Carrie Collier-Brown, lawyer for the Alliance for Retail Markets, a trade group for Texas electric providers. "For folks out there, it's better for their economy when gas prices are high."

But despite the spike in demand, the oil and gas industry isn't seeing major production growth because of a backlog of orders for vital equipment due to supply chain issues stemming from the pandemic, said Garrett Golding, energy economist with the Federal Reserve Bank of Dallas.

Patrice Willoughby, the NAACP's vice president of policy and legislative affairs, said the federal government already has some of the tools it needs to begin acting on the policy proposals.

"Unless there is sort of a holistic approach to stamp-



ing out hatred, we are never going to have the type of society in which people are free to live and work without fear," she said.

Across the civil rights community, Black activists echoed the NAACP's call for action to address white supremacy and violence.

Amara Enyia, policy and research coordinator for Movement for Black Lives, said it's important to acknowledge that the shooting in Buffalo was not an individual act of violence, but instead a symptom and evidence of a systemic problem that has grown significantly in recent years.

"These atrocities that are committed are systems, and they're systems of a structural and systemic cancer," Enyia said. "You have this person who is fueled by anti-Black racism and a society whose systems are built on anti-Black racism.

"When we understand that, it can't come as a surprise that this person would act out in this way, because he reflects a certain worldview that unfortunately undergirded the various systems upon which this society was built. And those of us who are organizers, activists, we've been working to try to dismantle these systems because they've been harmful."

Color of Change President Rashad Robinson noted that white supremacists and nationalists have access to wider audiences now and are able to spread hateful and dangerous rhetoric across various online platforms. Robinson has called for stricter regulation of social media platforms to prevent the proliferation of supremacist materials and ideologies.

"What we're seeing right now, with the dominance of social media platforms, is an unchecked corporate infrastructure whose incentive structures demand a type of engagement that makes going down the rabbit hole of white supremacy way more likely," Robinson said. "Until we actually have consequences on the 21st century, technological infrastructure, we will be a place where it's going to be dragging us back to the 18th and 19th century."

Jim Henson, director of the Texas Politics Project, said the mass shooting in Uvalde and scrutiny over how it was handled could have contributed Abbott's increased unfavorability, but it's hard to say how much exactly.

The political poll did not include specific questions related to the shooting in Uvalde, but it did ask participants to rate Abbott's performance on handling gun violence. About 36% of participants said they approve of how the governor has handled this issue, while 45% said they disapprove.

The mass shooting in Uvalde and the overturning of Roe v. Wade have laid the groundwork for a contentious final four months in the race to lead the state. While O'Rourke works to harness the anti-incumbent energy spurred by the seismic events of the past few months, Abbott is banking on a general election centered on stronger issues for him: the economy and the border.

Mounting expectations over how the Supreme Court would rule on abortion access could be another factor that contributed to Abbott's weakened ratings, Henson said. Although the poll ended the same day Roe v. Wade was overturned, it included questions about abortion access that show how voters feel regarding the issue. About 36% of participants said they approve of how Abbott has handled policies related to abortion access, and 46% said they disapprove.

Now that Roe v. Wade has been overturned and Texas is poised to completely outlaw abortion access, it will likely be a pivotal topic in the upcoming months, Henson said.

"If we look back at the half dozen times we've asked the standard abortion questions since 2014, no more than a quarter of Republicans have ever said that by law abortion should never be permitted," he

> Voters will see that reality reflected in how Abbott and O'Rourke discuss abortion access in the upcoming months, he said.

> Despite the ratings, Abbott carries most of the advantages in the race: His campaign is well funded for a midterm election that is expected to favor Republicans across the country.

"There's also a shortage of labor across most of the oilfield services," Golding said, noting that companies are trying to hire aggressively. "But we've seen it for several quarters now: It is a struggle to get qualified people into the positions (companies) want right now."

Is the price of natural gas the only cause?

While they agree the price of natural gas is the primary driver behind Texas utility bills, energy experts say there are other factors at play.

The state's main power grid operator, the Electric Reliability Council of Texas, has been managing the grid more cautiously since last February, when millions of people were without power for days in subfreezing temperatures after a combination of cold weather across the state and skyrocketing demand for energy shut down

power plants as well as the natural gas facilities that supply them with fuel. Hundreds of people died.

Public Utility Commission chair Peter Lake, appointed by Gov. Greg Abbott after the winter storm to lead the agency in charge of ERCOT, has said the grid operator is no longer prioritizing providing Texans cheap power. Instead, Lake said, its main focus is the grid's reliabiliespecially during extreme hot or cold weather. But that has a price.

"Conservative operations add costs," said Cathy Webking, a longtime Texas energy lawyer.

ERCOT's new approach to operating the grid means asking power plants to be online and available in case they're needed, and that means paying generators a prescribed price to operate no matter what happens. Before the 2021 winter storm, power plants ramped up or went offline based on market demand.

Federal Reserve Bank of Dallas, said Texans are paying for last year's grid disaster — and will for years. Texas lawmakers last year approved roughly \$7 billion in ratepayerbacked bonds to deal with the financial fallout from the storm. Some electricity utilities were strapped with billions in new debt after paying exorbitant prices for electricity set by ERCOT during the storm — the high prices were an incentive for power plants to provide more electricity — and the debt drove some utilities into bankruptcy.

"On everybody's bill, there are also these surcharges for paying for what happened in 2021," Golding said.

White House: Biden has read Griner letter pleading for help

Brittney Griner's appeal to President Joe Biden in a handwritten letter continued to garner reaction Tuesday after the WNBA All-Star acknowledged she feared never returning home and asked Biden not " forget about me and the other American Detainees."

Griner's letter was delivered through her representatives to the White House on Monday and officials say the president has read it. However Griner's wife, Cherelle, said Tuesday on a morning talk show that she hadn't heard from Biden.

White House press secretary Karine Jean-Pierre was asked repeatedly about Griner on Tuesday during the regular briefing. She said Biden read the letter, but she did not detail his reaction.

"This is very personal to

him." Jean-Pierre did not say whether there were plans for Biden to speak with Griner's family, but did say that National Security Advisor Jake Sullivan and U.S. Secretary of State Antony Blinken both spoke to Griner's wife recently.

Jean-Pierre said Biden wanted to get Griner and other Americans home.

"We are going to use every tool we possibly can to make that happen," Jean-Pierre said.

Griner is in the midst of a trial in Russia that began last week after she was arrested on Feb. 17 on charges of possessing cannabis oil while returning to play for her Russian team. The trial will resume Thursday.

Fewer than 1% of defendants in Russian criminal cases are acquitted, and unlike in U.S. courts, acquittals can be over-

Monday shared a few excerpts from her letter to the president. "...As I sit here in a

Griner's representatives

Russian prison, alone with my thoughts and without the protection of my wife, family, friends, Olympic jersey, or any accomplishments, I'm terrified I might be here forever," Griner wrote.

"On the 4th of July, our family normally honors the service of those who fought for our freedom, including my father who is a Vietnam War Veteran," the Phoenix Mercury center added. "It hurts thinking about how I usually celebrate this day because freedom means something completely different to me this year."

Cherelle Griner was disappointed not to have any direct communication with the White House since the letter was delivered.

"I still have not heard from him and honestly, it's disheartening," very Cherelle Griner said on CBS Mornings.

Cherelle Griner said for Brittney to reach out directly to Biden is an indication of just how afraid her wife is about what's next.

"BG is probably the strongest person that I know. So she doesn't say words like that lightly," Cherelle said. "That means she truly is terrified that she may never see us again. And you know I share those same sentiments. ... I'm sure she was like, 'I'm gonna write him now because ... my family has tried and to no avail. So I'm going do it myself."

Griner pleaded with Biden in the letter to use his powers to ensure her return. "Please do all you can to

bring us home. I voted for the first time in 2020 and I voted for you. I believe in you. I still have so much good to do with my freedom that you can help restore," Griner said "I miss my wife! I miss my family! I miss my teammates! It kills me to know they are suffering so much right now. I am grateful for whatever you can do at this moment to get me home."

Griner has been able to have sporadic communications with family, friends and WNBA players through an email account her agent set up. The emails are printed out and delivered in bunches to Griner by her lawyer after they are vetted by Russian officials. Once the lawyers get back to their office, they'll scan any responses from Griner and pass them back to the U.S. to send along.

She was supposed to have a phone call with her wife on their anniversary but it failed because of an "unfortunate mistake," Biden administration officials.

Griner's supporters have encouraged a prisoner swap like the one in April that brought home Marine veteran Trevor Reed in exchange for a Russian pilot convicted of drug trafficking conspiracy. The State Department in May designated her as wrongfully detained, moving her case under the supervision of its special presidential envoy for hostage affairs, effectively the government's chief hostage negotiator.

Griner isn't the only American being wrongfully detained in Russia. Paul Whelan, a former Marine and security director is serving a 16-year sentence on an espionage conviction.

Mississippi Team Uncovers Arrest Warrant for White Woman Who Lied About Emmett Till

chambers of Congress.

Named after Emmett Till, a 14-year-old African American savagely murdered by a group of white men in Mississippi, the legislation received push back from three Republicans - Andrew Clyde of Georgia, Thomas Massie of Kentucky, and Chip Roy of Texas.

Each were the lone votes against the bill.

Emmett Till's murder sparked the civil rights movement which ultimately led to bills like the Voting Rights Act of 1965 and other social justice laws.

"I could not have been prouder to stand behind President Biden as he signed the Emmett Till Anti-Lynching Act into law," National Urban League President Marc Morial stated.

"The act of lynching is a weapon of racial terror that has been used for decades, and our communities are still impacted by these hate crimes to this day," Morial continued.

"This bill is long overdue, and I applaud President Biden and Members of Congress for their leadership in honoring Emmett Till and other lynching victims by passing this significant piece of legislation."

According to the bill's text, "Whoever conspires to commit any offense ... shall (A) if death results from the offense, be imprisoned for any term of years or for life." "(B) In any other case, be subjected to the same penalties as the penalties pre-

scribed for the offense of was the object of the con-

Specifically, the legislation makes lynching a federal hate crime, punish-The measure had faced

defeat for more than 100 years, with lawmakers attempting to pass the legislation more than 200 times. The House finally passed the bill on a 422-3

It passed unanimously in the Senate.

The Mississippi search group included members of the Emmett Till Legacy Foundation and two Till relatives: cousin Deborah Watts, head of the foundation; and her daughter, Teri Watts, the Associated Press reported.

Further, the report stated that relatives want authorities to use the warrant to arrest Donham, who at the time of the slaying was married to one of two white men tried and acquitted just weeks after Till was abducted from a relative's home, killed and dumped into a river.

"Serve it and charge her," Teri Watts told the AP in an interview.

Beauchamp, Keith whose documentary film "The Untold Story of Emmett Louis Till" preceded a renewed Justice Department probe that ended without charges in 2007, was also part of the search.

He said there's enough new evidence to prosecute Donham.

Donham set off the case the commission of which in August 1955 by accusing the 14-year-old Till of making improper advances at a family store in Money, Mississippi.

The arrest warrant against Donham was publicized at the time, but the Leflore County sheriff told reporters he did not want to "bother" the woman since she had two young children to care for, the outlet continued.

Now in her 80s and most recently living in North Carolina, Donham has not commented publicly on calls for her prosecution. But Teri Watts said the Till family believes the warrant accusing Donham of kidnapping amounts to new evidence.

"This is what the state of Mississippi needs to go ahead," she said.

District Attorney Dewayne Richardson, whose office would prosecute a case, declined comment on the warrant but cited a December report about the Till case from the Justice Department, which said no prosecution was possible.

Contacted by the AP on Wednesday, Leflore County Sheriff Ricky Banks said: "This is the first time I've known about a warrant."
