

With 3 more victories, Biden pulls further away from Sanders

WASHINGTON (AP) - Joe Biden swept to victory in Florida, Illinois and Arizona on Tuesday, increasingly pulling away with a Democratic presidential primary upended by the coronavirus and building pressure Bernie Sanders to abandon his campaign.

The former vice president's third big night in as many weeks came amid tremendous uncertainty as the Democratic contest collides with efforts to slow the spread of the virus that has shut down large swaths of American life. Polls were shuttered in Ohio, and although balloting went ahead as scheduled in the three other states, election workers and voters reported problems.

Still, Biden's quest for

his party's nomination now seems well within reach. His trio of wins doubled his delegate haul over Sanders, giving the former vice president a nearly insurmountable lead. Top Democratic leaders and donors have also increasingly lined up behind Biden as the best option to square off against President Donald Trump in November.

Using a livestream to address supporters from his home state of Delaware, Biden seemed ready to move past the primary. He paid tribute to the Vermont senator for advancing key issues like affordable health care and combating climate change.

"Sen. Sanders and his supporters have brought a remarkable passion and tenacity to all of these issues. Together they have shifted the fundamental conversation in this country," Biden said. "So let me say, especially to the young voters who have been inspired by Sen. Sanders, I hear you. I know what's at stake. I know what we have to

With the exception of North Dakota and the Northern Mariana Islands, Sanders hasn't scored a victory since Super Tuesday on March 3. He made no immediate move on Tuesday to contact Biden, according to people familiar with the situation who spoke on condition of anonymity because they were not authorized to speak for the candidates. During remarks early in the night, Sanders said little about the future of the race and instead focused on the coronavirus outbreak.

Chris Bell, Michael Cooper Endorse Royce West for U.S. Senate

Senator Royce West (D-Dallas) has in the March 3 Democratic Primary. earned two key endorsements in advance of the May 26 Democratic Primary Runoff for United States Senate.

and Houston City Council Member Chris Bell announced his endorsement of Royce West Thursday afternoon in Houston.

Michael Cooper, a Beaumont pastor, former candidate for United States Senate, and President of the NAACP of Beaumont, announced his endorsement of Senator Royce West in the upcoming Democratic Primary runoff election in Beaumont Thursday morning.

Bell won more than 20 counties across Texas including a number of West Texas and Texas Panhandle counties such as Potter and Randall Counties, as well as Brazoria County along the Texas Gulf Coast, earning more than 158,000 votes

"I believe Senator West's experience in the Texas Senate is invaluable in this race. He is the only candidate now in this Former United States Congressman race with experience as an elected official in Texas," Bell said. "Senator West is a leader in the Texas Senate on such issues as banning assault weapons, protecting women's rights, and higher education, and has been for more than two decades," Bell said.

> "I am honored to endorse Senator Royce West in the Democratic Primary runoff election for United States Senate," Cooper said.

> Among the reasons Cooper cited as endorsing West was his strong work on education and higher education issues, criminal justice reforms, and voting rights issues.

Bell said he believed West was the helped lead to DeLay's downfall. only person in the race who could turn Texas blue.

"I am confident Senator West is the only person now in this race who can build the coalitions necessary to turn Texas blue this November," Bell said. "Senator West is also a fighter, and I'm confident he'll hold John Cornyn accountable for the many instances he's let down Texans by siding with Donald Trump and the GOP establishment," Bell continued.

Bell, a Houston attorney and former journalist, served on the Houston City Council and represented Houston in the United States Congress prior to the 2003 mid-decade redistricting scheme engineered by former U.S. House Majority Leader Tom DeLay (R-Sugar Land). He later served on the national board of

NARAL Pro-Choice America.

Cooper, the founding pastor of Beaumont-based The Church of I Am, won San Augustine and Jasper Counties in deep South East Texas, and came in second behind West in Jefferson County with 23.5 percent of the vote in the March 3 primary.

"Chris Bell is a leader in the Democratic Party. His courage in taking on Tom DeLay is the stuff of legend among Texas Democrats," West said. "I am honored to receive Chris's endorsement, and am grateful for his service to our state and our party," West said.



Q Ball





(AP) - Few prisons hold a larger place in the popular psyche than California's San Quentin State Prison. For more than 150 years the forbidding facility, perched on a crop of California coastline north of San Francisco, has served as a final stop for some of society's most notorious figures, including serial killers Charles Manson and Richard Ramirez, tabloid-fodder murderer Scott Peterson, and Robert F. Kennedy assassin Sirhan Sirhan. It served as the setting for one of Johnny Cash's most iconic live performances. There's little to live for inside its walls, and little chance for redemption. But there is basketball, and that's the focus of Q Ball, a stirring 2019 documentary film currently available on Netflix.

The film, executive produced by NBA superstar Kevin Durant, follows the San Quentin Warriors, a competitive basketball team made up of inmates in the prison and supported as an outreach program by Durant's former team, the Golden State Warriors. Coached by fellow inmate Rafael Cuevas, the squad

plays games against teams from outside the prison's walls, culminating their season with a "championship" game against members of the Golden State coaching staff. (One inmate hilariously notes, over a picture of players posing with the Warriors' NBA championship trophy, that "we got to do something Charles Barkley never did!")

Congresswoman Eddie Bernice Johnson Announces Federal Funding Toward Ending Homelessness in the City of Dallas



Washington, DC – Today, Congresswoman Johnson announced that the City of Dallas has been awarded a Continuum of Care Grant in the amount of \$287,443 from the U.S. Department of Housing and Urban Development.

"I am pleased to announce that the City of Dallas will be receiving \$287,443 in funding to support our Texans experiencing homelessness," said Congresswoman Johnson. "This funding will assist for our local government offices in their dedicated efforts to address housing insecurity in our communities. I am proud to support this federal funding, and I know the City of Dallas will put it to good use."

The Continuum of Care Program is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, States, and local governments to quickly re-house homeless individuals, families, persons fleeing domestic violence, and youth while minimizing the trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless individuals and families; and to optimize self-sufficiency among those experiencing homelessness.

This isn't some scrub prison-yard team, either. "For a lot of people, they could've gone in the NBA, at least gotten college scholarships," one inmate notes. "And for those dreams to be derailed, then come in here and have an opportunity to prove to themselves that I could've made it, that I was that good — it's huge, that's what they're really playing for." Another inmate concurs: "Some of these guys missed their calling. They should've been on a Division I basketball team, but for whatever reason they didn't make it. Then they come in here and they find out there's a legitimate basketball team? You can look at yourself in the mirror and say 'I can make it."

The filmmakers wisely make sure not to minimize the gravity of these crimes or sweep them into a simple redemption narrative, as sports media unfortunately can be prone to do — the Griffith murder is retold not only from Cuevas' perspective, but also by Griffith's grieving mother in an on-screen interview. It's understood that sports cannot heal the wounds or undo the damage these men have done, but the hope is that it can still be a vehicle for positive change.

"It's the easiest way to embrace guys that are the furthest from growth," Cuevas notes. "The toughest, meanest guys in the yard, the ones who are never going to go to therapy, but might play basketball." Being forced to be a part of a team, to work together toward a common goal, can be the beginning of restitution if not redemption.
