Michael and his family really were strangers over the last 25 years of his life.

They didn't know him and he really didn't care to know them.

His interactions with his brothers, whom he once led as the Jackson 5 and later as The Jacksons, were mere token visits on "Family Day" once a year.

During the 1993 investigation into Michael's alleged pedophilia, his sister Latoya created a firestorm by saying that she "would not be a silent collaborator in my brother's crimes against little children."

Latoya claimed that she and her mother had seen checks written out for "lots of money" to the families of her brother's alleged child Her mother, Katherine, "was so disgusted that she wrote a letter in which she used [a homophoslur] to describe Michael," Latoya alleged.

Katherine vehemently denied "every word Latoya had to say."

She'd been brainwashed, the Jacksons said.

For this reporter and onetime close family friend, their denials were shattered years later when the Jackson

family forfeited possession of a storage unit upon being sued in 2002.

That storage unit, Jermaine and Katherine would admit to me, contained "those checks and that letter" Latoya had spo-

Several Jacksons, including Jermaine, Rebbie, Katherine and even Joseph often confided in me and much of those discussions have confidential remained despite the sour ending to the friendship.

Jermaine and Rebbie both poured out their souls for book proposals.

Others including Tito, Jackie and Randy also often spoke openly.

"Michael is messed up," Randy has said.

One family member expressed his fear that "Michael may have touched [his son]."

My response at the time: Ridiculous.

His take: "I hope not," and "How would you know?"

Like him, I didn't really know. At the time, I had my doubts.

Michael's family often fumed about his "Carrying on with little white boys," though they never said he was molesting his special friends.

One morning in 2003, I received in succession, two phone calls pleading for my intervention. One from a girlfriend of Jermaine's and the other from one of Michael's nephews.

Both had the same concern: A teenage family member was telling others that Michael was guilty of bad behavior with little boys this was taking place while police were investigating

Authorities eventually questioned the teen family member and two lead detectives said the boy denied that Michael had done anything wrong, but they were convinced he knew a lot more than what he said.

One month before jury selection in Michael's 2005 trial, members of the Jackson family attended my wedding on Long Island.

At a dinner, a heated argument between two members ensued over whether Michael was a pedophile.

I interjected, "Let me ask you a question, you all still believe he was regularly high on drugs, correct?" Both agreed."Could it be possible that he behaved with these boys inappropriately while under the influence?"

The dissenting family member paused and con-

ceded to me: "You have a point."

While Safechuck declined to testify for Michael, Robson did.

And, despite being a "star" witness for the defense, Robson's testimony, and that of his mother, were amongst the most disturbing in a trial that made most observers feel "unclean."

Robson testified that he shared a bed with the King regularly of Pop Robson's mother, Joy, said Jackson would "cry like a baby" if she denied any of his requests to have a sleepover with Wade.

Detectives approached one family member during the trial in which Michael was acquitted on all charges.

That family member declined to take the stand for either side."I told them," the family member said. "I will tell you that Michael's a pedophile because I know that he is. But, take me to jail now because I'll never say that in court."

Sanders

Women Activists

"We are all bound up together in one big bundle of humanity," Dr. Crystal R. Sanders said during the Black History Month lecture Neville Hall Presbyterian College on Thursday, Feb. 28. "Society cannot trample on the weakest and feeblest of its members without receiving the curse in its own soul."

Sanders, associate professor of history and African American studies at Penn State University, was quoting Frances Ellen Watkins Harper, a poet and writer who lived from 1825 to 1911.

According to Sanders, Harper was telling a mostly white audience in 1866 that denying the freedom of African Americans indirectly weakened the freedom of white Americans.

"She was urging white women in particular to not just be progressive when it came to women's suffrage," Sanders said. "Harper wanted that resolve and commitment to extend to black civil rights."

Women Who Stood Up for Civil Rights

During her talk, which she noted came on the heels of Women's History Month, Sanders told the stories of several other lesser-known women, mostly African Americans, who stood up for civil rights for African Americans.

"Oftentimes in civil rights history, black women are relegated to secondary roles," Sanders said. "However, when we tell accurate, inclusive accounts of American history, women should be a key part of the narrative."

Sanders told the story of Ona Judge, who was enslaved to George and Martha Washington before she escaped the president's mansion. Sanders shared the story of Viola Gregg Liuzzo, a white civil rights activist from Michigan who traveled to Alabama to help Dr. Martin Luther King register African-American voters before she was killed for her advocacy.

Claudette Colvin, a pioneer Furthermore, all citizens

of the civil rights movement who was arrested when she was 15 years old for not giving up her seat on a bus, as well as the Bennett College Belles, who coordinated sitins at lunch counters in North Carolina. And Sanders noted Diane Nash, an American civil rights activist known for organizing sit-ins and continuing the Freedom

"Black women have been political strategists and leaders in their own rights," Sanders said. "They have been central to our country's social movements."

"We are all bound up together"

Sanders relayed that Americans must rely on one another today the same way Harper argued we must in

"This idea of interdependency is still true today," Sanders said.

For America to be America, Sanders argued, all citizens' rights should be protected and everyone Sanders also spoke about should abide by the law.

should be concerned about residential segregation, the re-segregation of public schools and the lack of living wages for all workers.

"It might not be our problem, but it is our problem," Sanders said. "It is our problem because we are all bound up together. A forgotten figure in history told us so more than a century ear-



Rep. Eric Johnson to File Anti-Corruption Bill in Wake of Latest Dallas Bribery Scandal

AUSTIN, TEXAS - State Rep. Eric Johnson said Monday he will file legislation this week to eradicate corruption surrounding the awarding of affordable housing tax credits.

Rep. Johnson, who sits on the House Urban Affairs Committee, announced his proposal just days after a former Dallas City Councilwoman pleaded guilty for accepting bribes from a real estate developer in exchange for her support of an affordable housing project. She was the latest elected official from Dallas found to have used their power over affordable housing programs for personal enrich-

When developers are seeking affordable housing tax credits, support from elected officials is part of the criteria used to evaluate those proposals. Under Rep. Johnson's bill, backing from elected officials would no longer factor into the evaluation and scoring process.

"Too many elected officials have abused their role in this process and abandoned their commitment to their constituents," said Rep. Johnson, D-Dallas. "These stories have become far too familiar, and I'm tired of reacting to the crimes. We need to prevent the crimes."



Official: Santa Anita cancels racing after 21 horse deaths



ARCADIA, Calif. (AP) — Santa Anita has canceled racing indefinitely to re-examine its dirt surface after the deaths of 21 horses in the last two months.

Tim Ritvo, chief operating officer of The Stronach Group, which owns Santa Anita, told The Associated Press on Tuesday that racing won't be held this weekend, when two major races were scheduled: the San Felipe for 3-year-old Kentucky Derby hopefuls and the Santa Anita Handicap for

Ritvo wouldn't speculate on when training and racing would resume. After this weekend, races were to be run again starting March 14 at the storied racetrack that will host the Breeders' Cup world championships for a record 10th time

"In whole, we feel confident in the track and we're just being very proactive," Ritvo said. "We want to do all the testing that needs to be done. When we believe we're in good shape, we'll start to train over it again."

The Daily Racing Form first reported the cancellation.

The latest fatality occurred during training on Tuesday, when a 4-year-old filly got injured and was euthanized.

"Obviously, one horse is too many," Ritvo said. "The recent rash is just horrible. We need to definitely take a step back and evaluate everything."

Santa Anita received 11½ inches of rain and had unusually cold temperatures in February, but it's unclear whether track conditions played a role in any of the fatalities.

The National Weather Service was forecasting 1 to 2 inches of rain in Los Angeles County starting overnight Tuesday and into Wednesday.

"We think that (rain) could definitely contribute even though our experts are telling us not," Ritvo said. "The tracks out here are built not for weather like that."

Ritvo said officials are "a little bit concerned" with the latest impending storm and how the dirt surface can change from muddy to fast in a short time.

Besides re-examining the dirt track, Ritvo said all racing protocols would be looked at.

"We won't rush it," he said. "Everybody takes a deep breath."

Ritvo was uncertain whether the San Felipe and Santa Anita Handicap would be rescheduled.

"Those are huge races," he said. "We hope so."

Seven deaths have occurred during races on the dirt oval at Santa Anita since the track's winter meet began on Dec. 26. Five have occurred on the turf course and nine came during training on dirt. The highest-profile horse to be euthanized was Battle of Midway, winner of the 2017 Breeders' Cup Dirt Mile. The 5-year-old bay also finished third in the 2017 Kentucky Derby for Hall of Fame trainer Jerry Hollendorfer. The horse suffered injuries during a workout on Feb. 23.

Last week, Santa Anita was closed for two days while the dirt surface underwent extensive testing and was declared fit for racing.

Hall of Fame trainer Ron McAnally said 4-year-old filly Lets Light the Way "took a bad step or something" on Tuesday.

He said the injury was a shattered sesamoid in her right front leg. Sesamoid bones provide anchor points for the two branches of the suspensory ligament. The bones are under stress each time a horse takes a step. Lets Light the Way was X-rayed and later euthanized.

"I think the weather has a lot to do with it," said McAnally, whose wife, Debbie, owned the filly.

"Santa Anita has been a wonderful track, and they've done all kinds of tests," McAnally said. "I don't know what else they could do. It's a fluky thing."

In 2017, 20 deaths occurred among a total of 8,463 starts over a span of 122 racing days at Santa Anita, according to the most recent figures compiled by The Jockey Club. That's a rate of 2.36 deaths per 1,000 starts.

There were 1.61 deaths per 1,000 starts in the U.S. in 2017, according to the most recent figures from the Equine Injury Database, compiled by The Jockey Club. That was a slight increase in the rate of fatal injury compared with 2016, when there were 1.54 deaths per 1,000 starts.

The deaths were more frequent on dirt surfaces (1.74 per 1,000 starts) than on turf (1.36).

Santa Anita was closed for two days last week while the dirt surface was tested.

Warriors draft first woman player into NBA 2K esports league

NEW YORK (AP) — After over three hours of sitting, waiting and stressing, Chiquita Evans heard her name called. She stood, smiled and put on a Warriors cap, striding to the stage backed by the loudest applause of the night.

Someone put a microphone in front of her and asked her how it felt. That's when she finally choked up.

"It changes everything," she said. "It means everything to me."

Evans became the first woman ever drafted into the NBA 2K League on Tuesday night, going in the fourth round to Warriors Gaming, which is operated by the NBA's Golden State Warriors. A former college and semipro basketball player, Evans is now the esports league's first female pro, one of the 126 players who will make between \$33,000 to \$37,000 per season, plus benefits and team housing.

No more sessions as a trainer at Planet Fitness. The Chicago native is heading to the Bay Area.

"It feels surreal," she said.

Evans was one of two women who qualified for the 2K League draft this year through the league's online combine. The other, Brianna Novin, was not selected but could still sign as a free agent.

The NBA runs the league in coordination with 2K game publisher Take-Two Interactive, and it did not have any women for its inaugural season. Prior to last year's draft, NBA Commissioner Adam Silver called the lack of gender diversity "a disappointment for all of us so far."

The league set out to solve that problem by holding focus groups with top women gamers to spot potential barriers. One key problem: Data showed that male players weren't passing the ball to their female teammates — something that wasn't accounted for when the league analyzed players to build the 2018 draft pool.

"It made us put more emphasis on how good a player was when they got the ball in their hands," said 2K League managing director Brendan Donohue. "That's the only part of it they can control."

The league also monitored communication between players more carefully at this year's combine, removing several players for sexist

That kind of harassment isn't new to Evans, or women in esports in general. One of the biggest challenges for women is finding teammates for games that rely so heavily on teamwork. Female gamers can try to ignore an offensive, trash-talking opponent — and there are plenty of those in the 2K community.

But just like in real life, you can't defend a pick-and-roll if your teammates aren't willing to communicate.

Evans has done most of her competitive gaming with a coed team - right now, five of its 12 players are women — and that's helped her thrive as a shot-creating small forward.

Her experience when gaming outside that team — with both teammates and opponents — hasn't always been as rosy.

"I've had sexual remarks put towards me," she said. "I get told I should be back in the kitchen. '2K is not for women,' I've had that. There's no question about that."

That doesn't mean the women won't face extra skepticism. Kimanni Ingram, another draft-eligible player, has played with Evans and respects the way she has navigated blowback from male gamers.

But even his compliments Tuesday came with a qualifier. "She has the basketball IQ for a girl," Ingram said. "Most people would be like, 'I'm playing with a girl. She's not going to know what to

do.' She knows what she's doing. You can tell." News of Evans' selection traveled fast. Warriors coach Steve Kerr

was asked about her prior to a game against Boston. "I think that's really cool that she's passionate and inspired and

broke a barrier," Kerr said. "That's awesome." "Esports has become a huge thing now," said Kevin Durant, Evans' favorite player. "More people who enjoy the game might get an opportunity to be professionals and make some money for themselves and

make some money. I think it's cool." Female gamers have had difficulty breaking into pro esports. Among the most popular circuits, League of Legends Championship Series and the Overwatch League have each had just one female player. Those

women both received ample praise and criticism on social media. The NBA wants to help Evans and Novin manage that. The 2K League has a transition program based on the NBA's rookie symposium, and it added sessions specifically for Evans and Novin to help them navigate their potential barrier-breaking roles, including help

with social media. One item 2K hopes to change soon: The video game still does not include any female players. Unlike EA Sports' NBA Live series — which includes WNBA rosters and the ability to create female players — NBA 2K is still male-only. Donohue says 2K is working to add women to

future versions of the game. That's not bumming out Evans right now. She's already

her to-do list for her new home in Oakland. "I'm going to see if I can do a real-life shooting competition with (Stephen) Curry," Evans said. "That's what I was known for. See if I can shoot with the best."

Little League to include Cuban youth players

HAVANA (AP) — Cuban baseball and Little League International say they are launching a relationship that will allow young Cuban players to participate in international Little League tournaments.

The agreement announced Wednesday follows a deal between Major League Baseball and the Cuban Baseball Federation that will allow Cuban players to legally play professionally in the United States for the first time.

The two organizations said that Cuba's roughly 170 programs for children between 4 and 12 will now be included in Little League's international programs, including the Little League International Tournament. The Cubans will have a chance to qualify at the Caribbean Region Tournament in Curacao in July.

The deal comes at a time of high tension between Cuba and the Trump administration, which is increasing pressure on the island's socialist government.

Dallas ISD Trustees approve mid-year raises for identified Operations positions

DALLAS — Trustees have approved the recommendations of a salary study conducted by the Texas Association of School Boards (TASB) calling for mid-year salary increases for certain job positions in Food & Child Nutrition Services, Police & Security, and Maintenance & Facilities Services, Construction Services, and Transportation Services. The action will result in pay scale changes and compensation increases for 61 percent of employees in those departments effective March 1, 2019.

The TASB study compared the salaries and pay scales for positions in the Operations division with average pay for similar positions in the Dallas labor market. Comparisons were based on jobs requiring similar skills, qualifications and responsibilities at other school districts and Dallas employers.

The study found that salary adjustments are needed to recruit and retain employees in grounds and food services. As a result the study recommended the district provide an immediate pay raise to employees in certain job categories to be more competitive in the market.

Among recommendations approved by

Food Services, Construction Services, and Transportation Services will receive immediate salary increases ranging from 9.6 percent to 15 percent. The anticipated cost for the raises for the remainder of the fiscal year is approximately \$1.6 million, which will be covered with funds from the district's general operating budget

TASB is currently conducting a second study to review the salaries of all other district employees. It's expected the findings will be presented to the board in April. Any recommendations for salary adjustments as a result of that study will be considered as part of the dis-

trict's 2019-2020 budget deliberations.
