When we had the three weeks of no action on the floor because ... we didn't have a speaker, they were okay with that because they don't believe in governance," Pelosi said in slamming Republicans.

lines and ticket agents during the first quarter of 2023.



of funding for critical programs like SNAP. "This must be averted," Krishnamoorthi asserted.

The day's events were as high on controversy as they were on tension, with recently ousted Republican Speaker Kevin McCarthy allegedly engaging in a physical altercation with Rep. Tim Burchett of Tennessee in the halls of Congress. "It was just a cheap shot by a bully," Burchett said. "And then I chased after him. And we had a few words." Rep. Matt Gaetz (R-Florida), orchestrated who McCarthy's removal, called for an investigation by the House Ethics Committee into McCarthy's actions.

In a separate incident, Senator Markwayne Mullin (R-OK) challenged the Teamsters president to a brawl during a Senate hearing, prompting Sen. Bernie Sanders (I-Vermont) to intervene and demand Mullin to "sit down."

Ultimately, House Democratic leadership endorsed Speaker Johnson's two-step continuing resolution in a statement, describing it as "devoid of harmful cuts and free of extreme right-wing policy riders." They pledged their support, urging Congress to unite in advancing supplemental national security and domestic policy funding requested by President Joe Biden.

The two-step continuing resolution extends funding for part of the government, including the Departments of Agriculture, Transportation and Veterans Affairs, through Jan. 19. It also funds the Department

of Defense and other remaining parts of the government through Feb. 2.

The U.S. government faced the risk of running out of funds at 12:01 a.m. on Saturday if the House failed to pass a continuing resolution. The potential shutdown would impact publicly funded agencies, causing work stoppages and leaving employees without pay.

"I want to cut spending right now, and I would like to put policy riders on the bill," Johnson demanded. "But when you have a threevote majority — as we do right now — we don't have the votes. So, what we need to do is avoid the government shutdown."

Senate Majority Leader Chuck Schumer told reporters he wanted the Senate to vote on the bill "as soon as possible."

"We cannot change the past; however, this decision provides the Army and the American people an opportunity to learn from this difficult moment in our history," Under Secretary of the Army, Gabe Camarillo, said in the release. At the Secretary's request, the Army Board for Correction of Military Records meticulously reviewed records related to the court-martial cases, officials affirmed. The unanimous decision was that significant deficiencies permeated the proceedings, rendering them fundamentally unfair. The board recommended setting aside all convictions and characterizing the soldiers' military service as "honorable." Deputy Assistant Secretary of the Army for **Review Boards Michael** Mahoney, overseeing the review, agreed with the decision. "With the support of our experts, our dedicated Board members looked at each record carefully and

came up with our best advice to Army leaders to correct a miscarriage of justice," Mahoney added.

The U.S. Department of Veterans Affairs said it actively supports family members affected by the correction of records, offering assistance upon receipt of the amended documents.

"It is a long time coming, but it is justice that is finally achieved," John Haymond, a historian, told the New York Times, which reported that the Army acted after it received a petition requesting clemency for the soldiers that had been written by Haymond and Dru Brenner-Beck, a lawyer. The duo cited trial transcripts and other records to show that the soldiers had been denied due process and other basic rights. "This isn't a political action. This is the Army internally fixing a problem that was the Army's problem 106 years ago," Haymond asserted.

WALKING AS CHILDREN OF GOD

#### EPHESIANS 5:1-6:9 PART IV

In the Pauline epistles, the word "walking" was used as a metaphor denoting one's personal conduct. In the first three chapters of this grand book of Ephesians, Paul expounded on the new life of the believers and the new unity they embraced together in the body of Christ. Beginning with chapter 4, the apostle began to apply those truths in a practical way. The word "walk" appears five times in chapters 4 and 5 (4:1, 17; 5:2, 8, 15).

Ephesians 5:1-6:9 may be outlined as follows: I. The Command to Walk in Love -Ephesians 5:1-7; II. The Command to Walk in the Light – Ephesians 5:8-14: III. The Command to Walk in Wisdom - Ephesians 5:15-21; IV. Following Biblical Guidelines for the Family and in Relation to Servants and Masters - Ephesians 5:22-6:9.

**IV.** Following Biblical **Guidelines** for the Family and in Relation to Servants and Masters -**Ephesians** 5:22-6:9.

Taking up the topic of God intended, the two part-

family relationships, Paul exhorted Christian wives to submit to their husbands (v. 22). Submission by a wife does not carry the idea that she is inferior to her husband or that she is the husband's doormat. However, she is called upon to voluntarily yield her rights to her husband in pursuing the different functions that God gave to each. The wife should submit not out of weakness, but from a position of strength. He submission is "as unto the Lord" (v. 22), not out of compulsion or grudging servitude.

The "husband is the head of the wife" (v. 23), meaning that he is placed in the position of exercising protective authority, just as Christ exercises authority over the Church. His authority is not a despotism, but a protective guidance. "He is the saviour of the body." The wife is exhorted to trust her husband and align herself under his leadership, just as "the church is subject to Christ" (v. 24). She is to do this "in everything", meaning that this is to be her consistent pattern. If the marriage is to be all that

ners need to fulfill the roles God gave them with enthusiasm and diligence!

The husband is exhorted to love his wife "even as Christ also loved the church" (v. 25). This exhortation involves complete self-sacrifice, for Christ "gave Himself" for the church by dying for her. In verse 26, Jesus had a high purpose in dying for the church. Christ's aim was to set the church apart to Himself by purifying her spiritually. This cleansing was "with the washing of water by the word" (v. 26). Christ's ultimate aim for the church is that He might present her to Himself glorious (v. 27).

Christ's church one day will be free from "spot or wrinkle, or any such thing." The church, which now is imperfect and marred in many ways, will one day be "holy and without blemish."

The husband is under obligation to love his wife in every respect that Christ loves the church (v. 28). This means that husbands will love their wives "as their own bodies." Just as the husband cares for his own needs, so he should care for the needs of his wife" (v. 29). In the same

way that a man looks after his own body, so the Lord looks after and cares for the church.

The closeness of a believer's relationship to the Lord is evident in the fact that he is "of His flesh, and of His bones" (v. 30). Marriage is the closest of all human relationships (v. 31). Husbands and wives become bonded or glued to one another spiritually, emotionally and physically in an unbreakable union. The word translated "joined" literally means "glued." Paul is quoting from Genesis 2:24, depicting the oneness of the marital union.

In marriage two people become so intimately united that they can be called one. Paul called this union "a great mystery" (v. 32). Speaking to husbands, Paul exhorted that each one "love his wife even as himself" (v. 33). The wife, in turn, is told to reverence her husband." She is to pay due respect to the authority and responsibility that God has laid on him, supporting rather than undermining his leadership.


Turning from his discussion of marriage, Paul turned to a discussion of children in the church (Ephesians 6:1).

Children are exhorted to obey their parents. This obedience is to be carried out "in the Lord", that is, under His ultimate authority and therefore in line with His commands in scripture. Such obedience is "right" or proper (v. 1). In addition, children are exhorted to "Honor thy father and mother", with emphases that this is a commandment with a promise attached (v. 2).

The promise of verse 3 should not be taken as an absolute guarantee of long life for everyone who honors his parents; however, children who learn obedience and respect live stable lives that promote longevity and success. Paul enjoined fathers not to provoke their children to anger or resentment (v. 4). Making unreasonable demands on children is an unacceptable practice. Instead of using unreasonable demands and brute force on children, fathers are to "bring them up in the nurture and admonition of the Lord" (v. 4).

In verse 5, servants are exhorted to "be obedient to them that are your masters according to the flesh, with fear and trembling, in single-



The servants were to treat their masters with respect and dignity. "In singleness of your heart" means there should not be any taint of duplicity. In verse 6, the servants should serve with right motives, not only with the master's eye on them, and with a sincere heart. The servants must also serve wholeheartedly, that is with good will or a peaceable spirit (v. 7).

The reason for such service is that the Lord will reward them (v. 8). The Lord is the One who can accurately and impartially judge their performance and motivation (I Peter 1:17). In verse 9, masters were to treat their slaves in the way, that is, to please the Lord in their dealings with them. Slave owners were not to keep threatening them but to treat them justly and fairly (Col. 4:1; James 5:4) because they themselves were servants, with a Master who is an example to them.

consumer submissions, including complaints, inquiries, and opinions, instead of focusing solely on complaints from June 1 to December 31, 2023, DOT officials said. Civil rights complaints will continue to be reported as usual. In March 2023, the DOT received 7,492 airline service complaints, a 12.8% increase from the previous month. It also represents a significant 70.1% surge compared to March 2022. For the first quarter of 2023, the Department received a staggering 24,965 complaints, indicating an 88.4% increase from the same period in the previous year. Complaints related to the treatment of passengers with disabilities also saw a notable uptick. In March, the DOT received 224 disability-related complaints, а marked increase from the previous month and a substantial rise compared to March 2022. For the first quarter of 2023, the DOJ registered 636 disability-related complaints, reflecting a notable surge from the previous year. The DOT announced it would invest in modernizing its consumer complaint application system to address those

The challenges. Department secured an \$8 million grant from the Technology Modernization Fund (TMF) to enhance its capabilities further. Officials project the upgraded system to operate by January 2024, with additional improvements planned through TMF funding in subsequent years. The initiative aims to improve the customer experience for the tens of thousands of consumers who use the system each year. Transportation Secretary Pete Buttigieg also emphasized the Department's dedication to ensuring fair treatment for airline passengers, highlighting the importance of data gathered in the ATCR for enforcement activities and rule adequacy assessments. "The DOT is committed to combating all forms of discrimination and will take action against carriers that violate Federal anti-discrimination statutes," Buttigieg stated, adding that efforts are underway to enhance lavatory accessibility on singleaisle aircraft and to potentially allow passengers to stay in their own wheelchairs when they fly.



## The 100 Club empowers women to get life-saving mammograms

Parkland's ambassador program uses education, action to fight breast cancer

DALLAS – Education and early detection are key in the fight against breast cancer, but getting there alone can be both nervewracking and confusing. That's why Parkland Health is creating a culture of support and sisterhood with The 100 Club, a community ambassador program for breast health awareness.

"We know that we can't win the fight alone, so we are in search of community ambassadors to help us

get the word out," said Aeisha Taylor, manager of mammography outreach and education at Parkland. "Sometimes a small nudge or affirmation from the women in your life can take you a long way."

The 100 Club got its name from its sole mission, to get 100 ambassadors to make a pledge to encourage at least one woman per month to get what could be a life-saving mammogram. It can be something as simple as

sending a text message, an email, making a post on social media or even hanging a flier in their neighborhood. Parkland will provide ambassadors with information, resources and hand-outs to be successful in their mission to raise breast cancer awareness in the communities where they live and work.

"We want to make sure that we are arming our ambassadors with the correct information," Taylor emphasized. "Oftentimes

we hear 'my cousin told me I needed this,' 'I heard my friend say this was true' so we want to make sure the information that is being spread in the community is truthful and informative."

But education is only one piece. The real magic happens when ambassadors drive their community to action by getting them signed up for a mammogram or RSVPing to an outreach event. Ambassadorship is not

limited to individuals. Organizations, faith communities and community groups are all invited to sign up as well.

"What we found is that a lot of people are already ambassadors, whether they know it or not," Taylor said, noting her experiences with women taking extra handouts at educational classes and signing up their friends, cousins and sisters for future events.

The 100 Club was born

when Taylor and her team realized the true potential of word of mouth as it relates to breast health. In engaging with women during outreach and educational events, the team noticed a pattern in their conversations. A large number of women were getting their information from other women in their circles, whether that was a coworker who had recently gotten a mammogram or a friend who survived breast cancer herself.





#### ELIGIBLE RETIRED TEACHERS TO RECEIVE COST-OF-LIVING INCREASE

SB 10 and HJR 2 passed during the 88th Regular Legislative Session to provide two types of benefit enhancements to eligible TRS annuitants (certain retirees, beneficiaries, and alternate payees who are receiving a monthly annuity from TRS).

TRS began issuing the first enhancement, one-time stipends, in September 2023. The second enhancement, the cost-of-living adjustment (COLA), was dependent on Texas voters approving a constitutional amendment (Proposition 9) in the November 7, 2023, election to authorize the COLA. Per the results, this passed by a majority of votes, and the COLA will be applied to eligible annuitants' payments beginning with their January 2024 payment (due the last business day of the month).

To protect the TRS Pension Trust Fund, the legislature passed HB 1 which provides \$5 billion to fully pay for the benefit enhancements:

- \$3.355 billion for COLAs
- \$1.645 billion for stipends

TRS will begin informing eligible annuitants and taking steps to provide the COLA. TRS is committed to ensuring that your constituents have all the information they need about this benefit enhancement. A webpage with details and answers to frequently asked questions is available at https://www.trs.texas.gov/Pages/benefit-enhancements-2023.aspx. Below are two that may be of particular interest to retired teachers.

What is the difference between a one-time COLA and an ongoing or automatic COLA? A one-time COLA is a permanent increase to your monthly annuity payment that you will continue to receive so long as you continue to receive that monthly annuity payment, but a one-time COLA does not entitle you to any subsequent adjustments. The COLA authorized by HJR 2, approved by Texas voters, is a one-time COLA for certain TRS retirees. The TRS pension plan does not currently provide for an ongoing or automatic COLA.

What if I can't remember when I retired?

TRS will send notification letters to eligible annuitants. If you have a MyTRS account, you can find your retirement date displayed in your account. If you haven't already registered for MyTRS, we highly encourage you to do so. There are enhanced security measures in place during the registration process to ensure your account is set up by you.

their anticipations of substantial backing on matters pertaining to voting and civil rights. The distinction between Manchin's stance and Republican endeavors to restrict voting rights adds layers of intricacy to his legacy. His earlier rebukes of former President Barack Obama, and his refusal to help a once-Democratic control Congress push legislation vital to communities of color may always be viewed as problematic.

With Manchin stepping down, Democrats' chances of keeping the coal country seat and holding on to their slim Senate majority are greatly handicapped and provides almost a guarantee that West Virginia voters, who supported the twiceimpeached and four-times indicted former President Donald Trump, will elect a Republican in 2024.

Sen. Kyrsten Sinema, a former Democrat who became an independent after last year's midterms, Manchin helped weaken Biden's plans for higher social spending to help underserved communities. Further, During Trump's presidency, Manchin was the only Democrat to vote in favor of confirming conser-Supreme Court vative Justice Brett Kavanaugh in

2018 and one of three Democrats to back another conservative, Neil Gorsuch, in 2017.

If Manchin does run for president, his record and ability to appeal to a wider range of voters will be closely looked at over the next few months. With a Democrat and a Republican leading the No Labels ticket, it could be the start of a new age of working together across party lines, or it could show how hard it is to get things done politically right now.

"I believe in my heart of Together with Arizona hearts that I have accomplished what I set out to do for West Virginia," Manchin stated. "I have made one of the toughest decisions of my life and decided that I will not be running for re-election to the United States Senate, but what I will be doing is traveling the country and speaking out to see if there is an interest in creating a movement to mobilize the middle and bring Americans together."
