NNPA Condemns Attacks on Israel

The support for Israel comes at a critical juncture, and it emphasizes the importance of solidarity with nations and communities facing acts of violence and terrorism.

Today, in a display of unity, the National Newspaper Publishers Association (NNPA), representing the Black Press of America, issued a resolute statement of support for Israel amidst the recent escalation of conflict in the Middle East.

In a joint statement released on Saturday, October 7, NNPA Chair Bobby Henry and NNPA President and CEO Dr. Benjamin F. Chavis Jr. unequivocally condemned the devastating acts of violence perpetrated against the Jewish people and the

nation of Israel by Hamas. The militant group's firing of a deadly barrage of rockets and infiltration of Israeli territory marked a significant escalation in the ongoing conflict between the two sides.

“The National Newspaper Publishers Association (NNPA), representing the Black Press of America, forthrightly condemns the brutal, fatal terrorist attacks today on the Jewish people and the nation of Israel by Hamas,” read the statement. “Terrorism against innocent civilians

in Israel and in any other place in the world can never be justified, tolerated, or sanctioned. We stand firmly in solidarity with Israel.”

The statement underscores the unity and solidarity between the African American and Jewish communities in the face of adversity. While their shared history is complex and nuanced, the NNPA's declaration underscores their shared common ground by condemning violence and

Biden-Harris Administration Unveils Sweeping Measures to Shield

In a bid to shield consumers from hidden and excessive charges, the Biden-Harris Administration, in collaboration with the Federal Trade Commission (FTC) and Consumer Financial Protection Bureau (CFPB), is set to implement a series of robust measures targeting junk fees across various industries while also prohibiting fees for essential bank services.

Junk fees, clandestine charges that businesses surreptitiously tack onto customer invoices, have long plagued American consumers, costing families billions annually and obstructing fair competition. In a

news release, the White House cited President Biden's previous call to arms for federal agencies, Congress, and private enterprises to combat these fees and ensure full-price transparency, culminating in these latest initiatives.

Administration officials said research indicates that fees levied after the point of purchase hinder consumers' ability to comparison shop, resulting in payments that can exceed the base price by up to twenty percent. “Such fees also unfairly disadvantage honest businesses, impede innovation, and disproportionately impact small enterprises,”

officials stated in the news release.

The Federal Trade Commission proposed a groundbreaking rule that, if enacted, would outlaw the imposition of hidden and deceptive fees, obliging companies to divulge the complete cost upfront. The regulation would encompass various sectors, including event tickets, accommodations, rentals, and more. Non-compliance could incur substantial penalties and necessitate refunds to consumers.

Meanwhile, the Consumer Financial Protection Bureau

The Israeli / Hamas War: A Warning for America

Those who follow the news know that in recent months, there has been an internal battle in Israel as the Prime Minister has sought to abolish the role of the Supreme Court, which serves as a check and balance over the legislation under Israel's democratic form of government.

This struggle led to massive protests, including members of the military pulling back on service as an expression of objection to the proposed changes. The next result: the conveyance of an internal conflict which led enemies of the State to decide it was a good time for an all out attack, especially during an

important Jewish holiday. The result of that internal conflict has cost more than 1000 lives in Israel and hundreds of Palestinian deaths.

Fast switch to America's democratic problems: A Legislative body unable to even pass a Resolution of support for Israel because of the lack of a Speaker in a Republican led House of Representatives, with a Democratic Party standing on the sidelines, with no will or incentive to help elect a new Republican Speaker. America has a crisis in leadership that is begging China, North Korea, Iran, Russia and all those who sympathize with them against the United States, to consider if this is not the time to become more aggressive with America. Like Rome, have we become so comfortable with our internal hate of those who don't look like us and the degree to which we no longer wish to help anyone but ourselves at the expense

decision raises significant concerns regarding the underlying intentions and potential consequences of this voucher proposal, particularly in terms of safeguarding the integrity of our public schools and upholding Texas's dedication to equal opportunity.

It's essential to remember that vouchers, historically, have been intertwined with attempts at segregation. For instance, in 1959, officials in Prince Edward County, Virginia, rather than desegregate their public schools in response to the Brown v. Board of Education decision, opted to shut down the entire public school system. White leaders then established private, whites-only schools, offering vouchers for white students to attend these institutions. This glaring use of vouchers to

maintain segregation underscores the profound implications such policies can have on our commitment to equal opportunity. In today's context, witnessing moves that could potentially echo such a troubling period in our history is deeply concerning.

The decision to omit protections against racial discrimination is a stark reminder that the fight for equality is far from over. Every legislative decision we make should unambiguously uphold our nation's founding creed from the Declaration of Independence: "that all men are created equal." By neglecting to include equal protection language in this legislation, we fail not only the students of Texas but also the fundamental values upon which our nation stands."

announced it is taking a stand against major financial institutions, mandating that they furnish essential information to consumers without charge. The move would eliminate fees for vital services like checking account balances, loan payoff details, and application-related account information.

Later this month, the CFPB plans to introduce a rule facilitating the secure and reliable transmission of banking transaction data among financial institutions. That measure aims to simplify the process of switching banks and managing accounts across multiple providers, thus encouraging competition based on service quality and upfront pricing.

The CFPB also revealed that its crackdown on junk fees has already delivered substantial savings to consumers. Bounced check fees have plummeted by over 86 percent since 2021, equating to nearly \$2 billion in savings, officials said in the release. Additionally, two-thirds of major banks have entirely abolished these charges. Coupled with prior reductions in banking junk fees, that action translates to an average annual savings of \$170 for the 33 million households affected.

The CFPB also announces a triumph in

securing an extra \$140 million in consumer reimbursements from companies guilty of imposing illegal junk fees, such as surprise overdraft charges and multiple bounced check fees for a single transaction. The White House said these announcements follow the issuance of guidance to financial institutions last October regarding these illicit fees.

Simultaneously, the White House said it bolstered its comprehensive approach to competition, with the Office of Information and Regulatory Affairs unveiling new guidelines to fortify the integration of competition-centric elements into agency regulations. Developed in concert with key economic councils, officials said the directive will steer agencies in designing regulations that foster competition while upholding other vital policy objectives.

Further, the Department of Transportation said it had successfully negotiated commitments from major airlines to enhance service quality, guaranteeing amenities such as meals, hotels, and family seating. Additionally, the Department of Housing and Urban Development

WALKING IN UNITY AS WE USE OUR SPIRITUAL GIFTS

EPHESIANS 4:1-16

As the grand Apostle Paul approached the mid-point of the book of Ephesians, he moved his focus from doctrine (chapters 1-3) to duty (chapters 4-6). As Rev. Jonathan Smith informed us in a Sunday morning sermon, a well-balanced saint knows that we are exhorted to practice our lofty position in Christ Jesus. In this section of Ephesians, Paul is exhorting the believers to walk in unity, utilizing our spiritual gifts in a loving and humble way! Ephesians 4:1-16 may be outlined as follows: I. An Exhortation to Walk in Unity – Ephesians 4:1-6; II. Blessed in the Granting of Spiritual Gifts from Christ – Ephesians 4:7-16.

I. An Exhortation to Walk in Unity – Ephesians 4:1-6

In verses 1-2, Paul began to build his super-structure of duty upon his doctrinal presentation in chapters 1-3. In Ephesians Paul explained in chapters 1-3 how all Christians are one in Christ, regardless of their ethnic differences. As he approached chapter 4, Paul began to explain how this Christian Unity should be practiced. Remember that our

lofty position in Christ (chapter 1) demands that it should be practiced in our conduct (chapters 4-6)! To put it another way, Ephesians 1-3 emphasizes our calling; Ephesians 4-6 emphasizes our conduct.

The word “therefore” in verse 1 points back to the whole argument of Paul in the first half of the book. On the basis of God’s grace in reconciling sinners to Himself and to one another, Paul strongly exhorted the Ephesians to walk worthy of their high calling (v. 1). Christians should live worthy of their calling in every facet of their lives. In Ephesians, Paul was vitally concerned about unity being exhibited within the congregation. Christian unity can be achieved when Christian attitudes are maintained in our relationships.

In maintaining unity within the body of Christ, Christians are called upon to exhibit “lowliness or humility” (v. 2). Christians are called upon to have the mind of Christ, who humbled Himself to become a servant and to die on the cross. Another attitude Christians need to embrace in maintain-

ing unity is “meekness.” Meekness refers to the ability to remain under control even when under attack. Another Christian attitude one should have is “longsuffering.”

Longsuffering is literally to be long tempered. He or she is not an irascible Christian (one who gets angry easily). The next Christian attitude to embrace is “forbearing.” Forbearing goes beyond doing to others as you want them to do to you.

Unity among Christians does not come automatically because we have been saved by grace through faith. As Christians, we still possess a sinful nature (Galatians 5:16-17) that responds in ways that would prompt division. Because of this fact, Paul urged the Ephesians to endeavor, or to be diligent, to keep the unity of the Spirit in the bond of peace (v. 3). True Christian unity can thrive in the body of Christ when we are diligent in maintaining it!

As we give our allegiance to practice these qualities, they will be bound together by peace, the active presence of goodwill. As Christians endeavor to maintain unity

within the body of Christ, Paul shared that we possess some spiritual resources that promote Christian unity (vv. 4-5)! As Christians, we belong to the same body of Christ, the church. We all possess the same indwelling Holy Spirit. We have all received the same divine call to salvation. We all serve the same Lord and exercise the same faith. We have all identified ourselves as Christians by the ordinance of baptism (v. 5).

Christian unity according to Paul is not an organizational structure imposed externally; however, according to Paul, it is an organic association that joins believers together from the inside! The final item that all Christians have in common is that they worship one God who is the Father of all (v. 6). As Sovereign of the universe, God rules over all things. He is the active God of history, who works through all events. As the omnipresent God, He is involved in every aspect of His creation!

II. Blessed in the Granting of Spiritual Gifts from Christ – Ephesians 4:7-16

In verse 7, Paul ascribes the giving of spiritual gifts to the ascended Christ, whereas, in I Corinthians 12:7-11, Paul attributes the giving of spiritual gifts to the Spirit. In supporting his point in verse 8, Paul quotes a prophecy from Psalm 68:18. In the psalm, God is pictured as a conquering warrior who receives the spoils of war. The psalmist went on in verse 19 to bless

the Lord who daily loads His people with benefits. As Christ triumphed over sin and death, He, like a victorious general, distributed gifts to those who served with Him. As the Lord of the church, Christ gives Christians various abilities (gifts) to serve Him and to minister to others.

In verses 9-10, Paul explains the significance of verse 8. Christ ascended back to heaven only after coming down to earth in humility to die on the cross (Phil. 2:5-8). By dying on the cross, Christ won the ultimate victory over sin, death, and the devil. The triumph of God’s grace in the crucifixion and resurrection enabled Him to give gifts to those who accept His grace by faith. In verse 7, Paul stressed that Christ gave gifts to each Christian. In verse 11, Paul spoke of the gifts Christ gave to the gifted leaders in the church.

Paul listed four groups of church leaders. The apostles were the original disciples of Christ (Acts 1:15-26). They were called to proclaim the news of Christ and the church. Prophets were the spokesmen through whom God made known His word before the canon of Scripture was established. For the continuing ministry of the church, Christ gave evangelists and pastors and teachers (v. 11). Evangelists focused on the outward expansion of the church as they preached the Gospel and brought people to Christ. The pastor-

teachers were charged with edifying Christians and building them up to spiritual maturity.

In verse 12, Christ gave gifted leaders to the church, and their role was to equip the believers. As they trained and developed the congregation, all Christians would be able to do the work of the ministry. Thus, the body of Christ will be built up. In God’s plan, ministry is the work of the whole congregation, not just the duty of a selected clergy.

In verse 13, the goal of teaching and edification is to cause people to be like Christ. In verse 14, when Christians do not receive spiritual nourishment, they do not grow up; thus, they will remain as spiritual infants. Like small rowboats caught in a gale, they can easily be tossed about by deception. Christians will fall prey to deceivers when they are not firm in their faith! To them, error can sound so true.

In verses 15-16, just as a child grows into adulthood, so God’s desire is that His children will reach spiritual maturity. This growth comes from consistent commitment to both truth and love. As we follow Christ’s example of truth and love, we will develop and become more like Him. In the body of Christ, all members are important to one another as we utilize our spiritual gifts in serving Christ, and as we minister to one another.

Kevin McCarthy Is No Longer Speaker of The U.S. House Of Representatives Who Will Be Next?

Embattled Speaker of The House, Kevin McCarthy is out. The sand in his hourglass signaled that it was time for him to go.

Unstoppable Simone Biles wraps up world championships comeback with 2 more gold medals

ANTWERP, Belgium (AP) — Simone Biles was not too worried about the medal count, or the color of the medals, at the gymnastics world championships this week.

That approach has sure paid off.

The American superstar claimed a third, then a fourth, gold medal on the final day of the 2023 competition on Sunday, winning the women's balance beam and floor finals in a dominant fashion.

In Antwerp — where she started her collection of 23 world titles 10 years ago as a 16-year-old — Biles has made a stunning return to the international stage. In addition to the pair of gold medals she won Sunday, she also claimed a silver medal on vault after the sixth all-around title that made her the most decorated gymnast in history, male or

female.

And, in the absence of Russian rivals because of sanctions imposed as a result of the war against Ukraine, Biles led the U.S. women to a record seventh straight victory in the team event.

"It's like as long as I get out there, do those routines again, like it's a win in my book," the four-time Olympic gold medalist said about how she approached the meet. "It doesn't matter if I end up on the podium or not."

Biles was competing at her first world championships since 2019 after a two-year break she used to focus on her mental health following the Tokyo Olympics. She only returned to competition this summer.

Biles was a bit worried on her comeback to the world stage, but the confidence of having trained

properly combined with what she called her new "whatever happens, happens" attitude helped her back to the top and demolish the competition.

She will keep the same laid-back attitude on the road leading to the Paris Olympics next year.

"I think we're going to take that approach, the same one that we took this year, just meet by meet and we'll see where we end up," said Biles, who applies herself to regular therapy sessions that helped her in her comeback.

Her coach, Cecile Landi, said Biles doesn't want to speak in detail about the Olympics yet to protect herself and avoid the pressure.

"But for us as coaches it's obviously the goal," Landi said. "And we will get her ready for that, if she wants it."

At the pandemic-delayed Tokyo Olympics, Biles was hampered by what's known as "the twisties" that gymnasts can experience while in the air, and withdrew from several events.

"I think I worried a little bit more about ending up on the podium and now I'm just like, I don't care," she said when asked how she now deals with pressure.

Biles has now won a record 37 medals at the world championships and Olympics.

On Sunday, she started the afternoon with a superb beam routine, oozing confidence throughout. She had no hesitation on her jumps and delivered controlled spins before dismounting in style, with just a small hop when landing. She earned a score of 14.800 points to win ahead of China's Zhou Yaqin by a margin of just 0.1 of a point. Rebeca Andrade of Brazil took the bronze medal.

Biles later took to the mat for her last appearance of a busy week, in the floor final. She had posted the highest score in qualifying and impressed again with a series of spectacular tumbling passes that wowed the crowd, reaching impressive height on her leaps.

Although she stepped out of bounds midway through her highly difficult routine, Biles earned the day's best score, 14.633 points. It was Biles' sixth world floor championship, a discipline where she remains undefeated.

Black America Divided Over Hamas' Attack on Israel, Raises Questions on Solidarity



Former NBA star Amari Stoudemire, who previously announced his conversion to Judaism, took a contrary stance, denouncing African Americans who do not support Israel. Stoudemire openly criticized the Black Lives Matter movement, asserting they were not contributing positively. He stated, "For all y'all Black Lives Matter who ain't saying nothing or 'let me figure out exactly what happened before I say anything,' F. you. Figure out what? It ain't never been cool to kidnap kids."

In a joint statement released on Saturday, October 7, NNPA Chair Bobby Henry and NNPA President and CEO Dr. Benjamin F. Chavis Jr. unequivocally condemned the acts of violence committed against the Jewish people and the nation of Israel by Hamas. The statement emphasized that Hamas' actions, including firing rockets and infiltrating Israeli territory, significantly escalated the ongoing conflict between the two parties.

"The National Newspaper Publishers Association (NNPA), representing the Black Press of America, forthrightly condemns the

brutal, fatal terrorist attacks today on the Jewish people and the nation of Israel by Hamas," read the statement. "Terrorism against innocent civilians in Israel and in any other place in the world can never be justified, tolerated, or sanctioned. We stand firmly in solidarity with Israel."

Despite this, a different social media user expressed skepticism, asking, "When has anyone in Israel said to pray for the American Negro? Our Holocaust has been ongoing for 400+ years. Has Israel ever told the USA not to send any money until after it repairs Black Americans? I mean, it's biblical to take care of your own family first."

Experts said the diverse range of opinions within the Black American community underscores the complexities and multifaceted nature of the ongoing debate surrounding the conflict in the Middle East and its implications for various social justice movements. Further, many observed that, as the situation continues to evolve, how these perspectives will shape the discourse within the Black community and on the broader global stage remains to be seen.


Black Americans have expressed a range of emotions regarding Hamas' recent and deadly attack on Israel, with many taking to social media to highlight what they perceive as a lack of support from Israel and some members of the Jewish community for the Black Lives Matter Movement.

The sentiment was especially pronounced after George Floyd's assassination in Minnesota in 2020.

Numerous posts on social media platforms feature hashtags like #BLM and #PLM, underscoring the perceived parallels between the struggles of Palestinians and African Americans in their fight against systemic racism.

One widely circulated message emphasized the cross-border nature of these movements, stating, "Palestinians & African Americans have been [creating] a social movement, without borders, to fight systemic racism. As part of international protests, in Palestine/Israel signs read 'Justice for Eyad. Justice for George.', 'Black lives MATTER. Palestinian lives MATTER.'"

Another post drew attention to what the author viewed as a lack of awareness about the treatment of Black people in Israel, saying, "If African Americans Knew How Israel Treats Black People, Black Lives Don't Matter in Israel."
