## Legislation affecting voting rights brings cause for alarm over future of democracy

Despite that it happened early in the pandemic, the high voter turnout of the 2022 election has prompted some states to adjust

their voting laws. After concerns over virus transmission prompted states and local authorities to support mail-in voting and

drop boxes, some states have chosen to adopt those practices permanently, National Organization for Women reports.

Seeing their success, Nevada and Vermont will continue to mail ballots out to all active registered voters for future general elections. Others will expand voter access by allowing mail-in ballots without excuses, Politico reports.

Some states have gone the opposite route, making voter laws more restrictive. Republican-led states, citing false claims of voter fraud, have passed bills limiting drop boxes and mail-in voting, and shortening the time allowed to vote.

Legislative moves across different parts of the country have raised concerns from those who fear stepping back from the gains made in the 1960s.

Georgia, known for longer wait times in black areas, now makes it a misdemeanor to distribute food and water to voters, reports Poynter the Institute. Other laws limit assistance to mail-in voters and hold to strict signature requirements.

Alternative efforts to suppress the vote are through electing candidates who subscribe to Donald Trump's philosophies of overturning elections and intimidating election officials. Alex Koppelman of CNN suggests that if Republicans take over the Senate or the House, and if another Trump-inspired

Republican runs for president, "there may be no stopping the tide."

Secretaries of state offices may be most important, as overseers of elections and influencers of public opinion. Barbara McQuade of Time reports, there are least 17 election deniers of the 27 secretaries of state to be elected this fall.

Kansas House Bill 2332 prevents the executive and judicial branches from changing election laws by transferring some key powers of election administration to the legislature.

Then, there are efforts to suppress certain types of voter turnout by restricting the type of Voter ID accepted at the polls. These laws tend to negatively affect those In lower income neighborhoods and in areas with a history of segregation, where many may not own a car or have a driver's license. For these citizens, obtaining voter I.D.s and birth certificates may be more difficult, National Organization for Women reports.

Similarly, restrictions that require the exact same name on all government documentation hurt women and LGBTQIAs, who have a tendency to experience name changes, they report.

Other efforts to control the vote allow concealed carry permits, while not accepting student IDs as a valid form of identification. One such state is Texas.

Despite the brave walkout Texas Democrats organized to avoid our massive voting rights bill, S.B. 1 bans drive-thru voting, tightens documentation requirements for mail ballots, limits polling hours, and allows partisan poll watchers.

There is also an increasing tendency for states to purge voter registration rolls. Iowa has justified purging its "bloated voter rolls" by reducing opportunities for voter fraud, as reported by CBS News. New Iowa election laws will make voter status "inactive" after skipping one election and cancel voter registration for those who skip just four years of voting.

Other limits on voter registration come by not allowing voters to register on election day. Montana recently ended its election day registration option, which the state had successfully used for 15 years. The state has even gone so as to ban voter education and registration efforts at public colleges. In a similar way, Florida has been targeting get-out-the-vote and third-party voter registration organizations that encourage civic engagement.

## Ye dropped by talent agency documentary on him scrapped

NEW YORK (AP) — A completed documentary about the rapper formerly known as Kanye West has been shelved amid his recent slew of antisemitic remarks.

MRC studio executives Modi Wiczyk, Asif Satchu and Scott Tenley announced in a memo Monday: "We cannot support any content that amplifies his platform." Ye was recently restricted from posting on Twitter and Instagram over antisemitic posts that the social net-

works said violated their French policies. He has also suggested slavery was a choice and called the COVID-19 vaccine the "mark of the beast." Earlier this month, Ye was criticized for wearing a "White Lives Matter" T-shirt to the showing of his latest collection at Paris Fashion Week.

Wiczyk and Satchu are cofounders and co-CEOs of MRC Entertainment. Tenley is the chief business officer. Shelving the documentary comes just days after the

fashion house Balenciaga cut ties with Ye, according to Women's Wear Daily.

In their lengthy memo, Wiczyk, Satchu and Tenley reach deep into the history of antisemitism.

"Kanye is a producer and sampler of music. Last week he sampled and remixed a classic tune that has charted for over 3000 years — the lie that Jews are evil and conspire to control the world for their own gain. This song was performed

acapella in the time of the Pharaohs, Babylon and Rome, went acoustic with The Spanish Inquisition and Russia's Pale of Settlement, and Hitler took the song electric. Kanye has now helped mainstream it in the modern era," they wrote.

Ye's talent agency, CAA, has dropped him as well. That news Monday and the scrapped documentary comes after UTA CEO Jeremy Zimmer condemned Ye in a companywide memo denouncing antisemitism.

## I CORINTHIANS STUDY I Corinthians 1:10-31 A DIVIDED CHURCH

By Rev. Johnny Calvin Smith

Beginning in verse 10, we come to a new division in this grand epistle where the Apostle Paul began to address the primary problem facing the Corinthian church. Paul admonished Corinthian church to "speak the same thing" and that "there be no divisions among you", but that they "be perfectly joined together in the same mind and in the same judgment." A church may be highly gifted, however, divisions within it can create problems. The divisions within a church such as gos-

sip, backbiting, criticism and hatred can bring about disunity within the body of Christ. Paul admonished this church to "be perfectly joined together in the same mind and in the same judgment."

You might ask, "What is the same mind?" The obvious answer is "the mind of Christ," the submissive mind! (see Philippians 2:5-8). The Apostle Paul had been informed that there were contentions in the church, and he was informed first-hand by those of the household of Chloe (v. 11).

The contentions within the Corinthian church included such sins of the flesh as strife, quarreling, schisms and wrangling. These sins of the flesh can really bring about disunity within the body of Christ!

One of the problems in the Corinthian church was that the church had formed "cliques around certain men" (v. 12). The believers in Corinth were divided over different leaders of the church (vv. 12-13). Thus, Paul will stress to them that the centrality of Christ is the

key ingredient in solving the factions and fractures in the The Corinthian church was definitely not unified, and obviously, there was no fellowship in the body! The Corinthian church needed to be occupied with the person of Christ, and not to be forming cliques around church!

In verses 14-17, Paul draws this church's attention to the fact that he didn't baptize many but was focused on preaching the gospel. The gospel message should bring about unity, not disunity. preaching of the cross will divide the saved from the unsaved. On another note, the preaching of the cross should not divide saved peo-

We should be unified, not a church characterized by schisms and strife within the

preaching of the cross of Christ divides the world, but it does not divide the church! Paul went on to stress that "the foolishness of preaching, not foolish preaching, will save them that believe" (vv. 19-21). Men are not saved by the wisdom of this world; different leaders of the rather, they are saved by the foolishness of preaching when they believe. From verses 22-23, Paul

body of Christ. Again, the

divided mankind into two groups: Jews and Greeks (Gentiles). The message of a crucified Christ was a stumbling block to the Jews, and it However, in verse 18, the was foolishness to the Gentiles because it did not conform to their philosophical way of thinking! As believers today, we must stress that God is saving men today by the "foolishness of preaching" as they believe the gospel, and not by the wisdom of this world.

From verses 24-27, Paul emphasized that through the power and wisdom of God, He has called and transformed the lives of both Jews and Greeks, even those who were not considered wise, mighty or noble. Believers may seem foolish and weak in the estimation of the world but God's method in saving us is through the foolishness of preaching when we believe; therefore, we will have no basis to boast about anything, but that God will get the glory! (vv. 28-29).

In verses 30-31, we need to glory only in the Lord. Christ is the source of everything we need: He has been made to us wisdom; He is our righteousness, sanctification, and redemption. We need to glory in the Lord Jesus Christ and not in ourselves!

This year, residents selected from six tree species including Mexican oak, sycamore, redbud, American elm, cedar elm, and chinquapin oak, to plant in their yards. ## Things One Should Know About Halloween

Halloween is once again upon us, with more spending than last year, in spite of the pandemic. Last year 2021, Americans spent a total of \$10.1 billion on Halloween. This year it is projected that expenditures by this same group of Americans will exceed \$1.6 billion. It is anticipated that "people will resume related activities associated with Halloween at pre-pandemic levels with 69% of consumers planning to celebrate the holiday this year, up from 65% in 2021 and comparable to 68% in 2019," according to the National Retail Federation (NRF). Here are some of the reasons for the increase in cost. The cost of candy has increased this year by more than 13.1% over September of last year.



## Attorney Ben Crump Files Lawsuit on Behalf of User of Chemical Hair Straightening Products

Crump and Zimmermann filed the suit on behalf of Jenny Mitchell, a woman with no family history of cancer but who received a uterine cancer diagnosis after years of using L'Oréal products.

Researchers have discovered that hair products used predominately by Black women are likely to contain hazardous chemicals with endocrine-disrupting and carcinogenic properties.

Armed with that information and research by the Journal of the National Cancer Institute, civil rights attorney Ben Crump joined forces with lawyer Diandra Debrosse Zimmermann to file a lawsuit against beauty products giant L' Oréal USA.

Crump and Zimmermann filed the suit on behalf of Jenny Mitchell, a woman with no family history of cancer but who received a uterine cancer diagnosis after years of using L' Oréal products.

The lawyers declared that the defendants also would include "entities that assisted in the development, marketing, and sale of the defective products including Motions, Dark & Lovely, Olive Oil Relaxer, Organic and Root Stimulator."

"Black women have long been told they must use chemical hair straightening products to meet society's standards," Crump declared. "Companies took advantage of this and marketed their dangerous products to women without any regard for the serious health risks. We need justice."

Crump said Mitchell started using the products around 2000 and continued until 2022.

In August 2018, Mitchell – with no family history of uterine or other cancer was diagnosed with uterine cancer and underwent a complete hysterectomy, Crump noted.

Mitchell attended mandatory medical appointments every three months for two years and has appointments scheduled every six months.

Crump cited a new study published in the Journal of the National Cancer Institute this week.

The study concluded that frequent users of chemical hair straightening products, defined in the study as more than four uses a year, were more than twice as likely to develop uterine cancer than those who didn't use those products.

The National Institute of Health's National Institute of Environmental Health Sciences conducted the study.

Uterine cancer rates and deaths are reportedly on the rise in the U.S.

Death rates are highest among non-Hispanic Black women, who are more likely than other populations to be afflicted with aggressive subtypes of uterine cancer, according to the National Institutes of Health, which tracked data from 34,000

women in the Sister Study for more than a decade.

"Black women have long been the victims of dangerous products specifically marketed to them," said Crump. "Black hair has been and always will be beautiful, but Black women have been told they have to use these products to meet society's standards. Unfortunately, we will likely discover that Ms. Mitchell's tragic case is one of the countless cases in which companies aggressively misled black women to increase their profits."

Chemical hair straighteners typically contain products associated with higher cancer risk, including formaldehyde, metals, phthalates, and parabens, which may be more easily absorbed by the body through scalp burns and abrasions often caused by chemical straighteners, study authors determined.

Zimmermann added that companies like L' Oréal "targeted Black and Latin women for their own profit motive and without regard to the serious health risks that these hair-straightening products cause is a serious wrong that needs to be corrected."

"We have commenced this important litigation to seek and obtain justice for those women and their fam-

## Slavery is on the ballot for voters in 5 US states

NASHVILLE, (AP) — More than 150 years after slaves were freed in the U.S., voters in five states will soon decide whether to close loopholes that led to the proliferation of a different form of slavery — forced labor by people convicted of certain crimes.

None of the proposals would force immediate changes inside the states' prisons, though they could lead to legal challenges related to how they use prison labor, a lasting imprint of slavery's legacy on the entire United States.

The effort is part of a enslavement or involuntary servitude except as a form of criminal punishment. That exception has long permitted the exploitation of labor by convicted felons.

"The idea that you could ever finish the sentence 'slavery's okay when ... ' has to rip out your soul, and I think it's what makes this a fight that ignores political lines and brings us together, because it feels so clear," said Bianca Tylek, executive director of Worth Rises, a criminal justice advocacy group pushing to remove the amendment's convict labor clause.

Nearly 20 states have constitutions that include language permitting slavery and involuntary servitude as criminal punishments. In 2018, Colorado was the first to remove the language from its founding frameworks by ballot measure, followed by Nebraska and Utah two years later.

This November, versions of the question go before in voters Alabama, Oregon, Louisiana, Tennessee and Vermont.

Sen. Raumesh Akbari, a Democrat from Memphis, was shocked when a fellow lawmaker told her about the slavery exception in the Tennessee Constitution and immediately began working to replace the language.

"When I found out that this exception existed, I thought, 'We have got to fix this and we've got to fix this right away," she said. "Our

Similar concerns over the financial impact of prison labor led California's Democratic-led Legislature to reject an amendment eliminating indentured servitude as a possible punishment for crime after Gov. Gavin Newsom's administration predicted it could require the state to pay billions of dollars at minimum wage to prison inmates.

The nonprofit Council for Scrutiny over prison a Better Louisiana warned that the wording could technically permit slavery again, as well as continue involuntary servitude.

Louisiana's Constitution now says: "Slavery and involuntary servitude are prohibited, except in the latter case as punishment for a crime." The amendment would change that to: "Slavery and involuntary servitude are prohibited, (but this) does not apply to the otherwise lawful administration of criminal justice."
